The Council of the City of Burnaby ENACTS as follows:



SCHEDULE "D"

Removal, Disposal and Cremation Fees

- (1) For each dead body of a horse, mule  
ass, cattle, sheep, goat or swine \$50.00
- (2) For each dead body of any other animal  
or poultry not included in item (1), but  
excluding dogs or cats \$2.00
- (3) There shall be payable in respect of  
the animals or poultry described in  
items (1) and (2) in addition to the  
fee specified therein, all costs of  
removal and disposal
- (4) Notwithstanding anything in this  
Schedule contained, licenced  
veterinarians and other agencies  
approved by Council shall pay for the  
disposal of animals and poultry \$.27 per pound  
With minimum  
charge of \$6.60
- (5) For each dead body of a cat or dog \$.27 per pound  
With minimum  
charge of \$6.60
