BYLAW NO. 9952

A BYLAW to regulate the location of billiard halls  
and amusement arcades

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY ZONING BYLAW 1965, AMENDMENT NO. 46, 1993.

2. Section 3 of Burnaby Zoning Bylaw 1965 is amended

(a) by adding thereto, immediately after the definition "accessory use", the following definition:

"'amusement arcade' means a commercial undertaking containing six or more pinball, videogame or other game machines available for the use of its patrons, but does not include an establishment holding a Class "A", "C", "D", "F" or "I" licence under the Liquor Control and Licensing Act, a club or lodge nor a children's amusement facility where game machines are designed primarily for the use of children under the age of thirteen;"

(b) by adding thereto, immediately after the definition "bedroom", the following definition:

"'billiard hall' means a commercial undertaking containing two or more billiard or pool tables available for the use of its patrons, but does not include an establishment holding a Class "A", "C", "D", "F" or "I" licence under the Liquor Control and Licensing Act, an apartment building, a hotel or a club or lodge;"

3. Section 5.1 of the said Bylaw is amended
  - (a) by striking out the letters, numbers and symbols "C2 and C2a" and substituting therefor "C2, C2a and C2c";
  - (b) by striking out the letters, numbers and symbols "C3 and C3a" and substituting therefor "C3, C3a and C3c";
  - (c) by striking out the letter and number "C4" and substituting therefor "C4 and C4c".
  
4. Item (7) of section 302.1 of Schedule Number III is amended by striking out "billiard and pool halls,".
  
5. Schedule Number III is further amended by adding thereto, immediately after section 302.1A, the following section:

"302.1B Uses Permitted in a C2c Zoning District:
  - (1) Uses permitted in Community Commercial District C2.
  - (2) Billiard Halls."
  
6. Item (13) of section 303.1 is amended by striking out "amusement arcades, billiard and pool halls,".
  
7. Schedule Number III is further amended by adding thereto, immediately after section 303.1A, the following section:

"303.1B Uses Permitted in a C3c Zoning District:
  - (1) Uses permitted in General Commercial District C3.
  - (2) Amusement arcades.
  - (3) Billiard halls.



8. Item (23) of section 304.1 is amended by striking out "amusement arcades, billiard and pool halls,".

9. Schedule Number III is further amended by adding thereto, immediately after section 304.1, the following section:

"304.1A Uses Permitted in a C4c Zoning District:

- (1) Uses permitted in a Service Commercial District C4.
- (2) Amusement arcades.
- (3) Billiard halls."
