A BYLAW respecting animal fees

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY ANIMAL CONTROL BYLAW 1991, AMENDMENT BYLAW NO. 2, 1993.
2. Schedules "A", "B", "C" and "D" of Burnaby Animal Control Bylaw 1991 are repealed and Schedules "A", "B", "C" and "D" hereto are substituted therefor.
