

Bunaly Hall

20 Dec 1902, 2.30 pm.

At a Council meeting held time and place as above there were present the Reeve (in the chair) and Councillors Oliff, Smith, Spitt & Stude.

The minutes of last meeting were read and confirmed.

Councillor Smith reported that the Inter-Committee had met Bogart's Council that morning and had viewed the North road together, and let a contract for \$20⁰⁰ to Geo R Love to make a temporary deviation on to the new road from the old road. The report was adopted.

An appeal for the Bénédictine Fund of the new General Hospital at Vancouver was laid over for the new Council to deal with.

The Reeve reported the sense of a writ in re John G. v. The Corp. v. Henry Tom & Bunaly, and that if the plaintiffs upset the Tax deed, the difference between the Sale price & the Redemption money would be over \$300⁰⁰ to the benefit of the municipality.

Also the proceedings at the Reeve's Convention held Dec 19th.

Mr E. L. Webber was re-appointed Auditor on the same terms as before.

The Clerk was instructed to give Mr Cook, 10 days wherein to perform the work ordered by the Council 29 Nov 1902, or further proceedings would be taken.

Councillors Oliff & Spitt were empowered to obtain foundation broken rock for Hartung St.

The Clerk was ordered to advertise a public meeting of tax-payers at Bunaly Hall on Saturday Jan 10 at 3 p.m., in the Columbian (d & w) Ward (d & w) Press & News-Advertiser.
