At a meeting of the Council held, in pursuance of adjournment, at the Municipal Hall on Saturday, April 28. 1906

Assessment Roll. The clerk asked for a weeks further time for returning Assessment Roll on account of his having been called away to Conference re Water Supply, and to the late receipt of Assessments of Lot 172 from Provincial Surveyor.

Resolved: That the time for return of the Roll be extended to May 25, and that the date of Court of Revision be June 9th 1906. Notice of such Court to be published in the B. C. Gazette and the Columbian Weekly.

Water Supply. The clerk reported his having attended the joint committee called at the City Hall Vancouver on the previous day. After a lengthy argument on all sides the following basis of agreement was arrived at

The various representatives agreed to submit the above basis of agreement to their respective Councils for endorsement.

The Hon. J. Carter-Cotton (Member for Richmond Riding) and Mr. C. C. Fisher, Water Commissioner were present at the Conference.

Resolved: That the report be received and adopted upon the understanding that the terms set forth are carried out by all parties in their entirety and also without prejudice to the rights of the Council under Sec. III of the Water Clauses Consolidation Act.

1084 Debt Payment. Resolved: That the Reeve and the Chairman of the Finance Committee be, and they are hereby, authorized to sign a cheque for \$337⁵⁰ in favour of The Bank of Montreal to meet interest on \$10,000 Debentures due May 1st \$300 and half year repayment to Sinking Fund \$37⁵⁰.

1085 Resignation of Auditor. Mr. S. Shepherd wrote resigning his office of Auditor on account of his appointment as C. M. C., Assessor and Collector of Richmond Municipality.

Resolved: That the resignation be accepted.

1086. Grants to Exhibitions. The Manager of the New Westminster Provincial Exhibition and the Secretary of the South Vancouver Central Park Agricultural Association, wrote asking for grants towards their respective Prize Funds.

Resolved: That a sum of Fifty Dollars be granted to the New Westminster Prize Fund, and a like sum of Fifty dollars to the Central Park Prize Fund.

1087 Tax Sale Deed. The Deed of Conveyance from the Reeve and Municipal Clerk, to the Corporation of properties bought in by the Corporation at the 1904 Tax Sale and not since redeemed, was submitted for execution.

1106. Resolved: That the clerk publish the vacancy and call for nominations by notices affixed at the Hall and within the Wards.
- 1107 Hastings Road. The tender of John H Ledger for taking up 200 ^{feet} ~~yards~~ of Corduroy, trenching out the road and filling in with large rock for the sum of 24^c per foot, be, and the same is hereby, accepted.

- 1108 Mr. Wearts Wall fence. Permission was given for Mr. Weart to erect temporary fence in front of his property during construction of wall fence, and to remove the same at the pleasure of the Council.
- 1109 Chairman of Finance Committee. Resolved: That Councillor Griffin be, and he is hereby, appointed Chairman of the Finance Committee vice Mr. B. R. Hill resigned.
- 1110 Burnaby Post office. Attention was called to the frequent inconvenience caused by the delay in delivery of mail matter in consequence of its being sent to Burnaby Lake when addressed as Burnaby.
Resolved: That the Council favour the alteration of the name of the Post office at the Lakes to "Deer Lake" Post Office and that the residents of the district be invited to present a memorial to the Post Master General asking that the alteration may be made.
1111. Adjournment. Resolved: That the Council adjourn till Saturday, May, 5. 1906 at 2.30 p.m. being pay day.
