673. Resolved that a special meeting of the whole Council be appointed to take up the question of errors in surveys.

674. Councilor Caldwell reported that Chairman of Board of Works had agreed on behalf of City Council to share one half the cost of staking and burning Tenth Avenue.

Resolved that report be adopted and copy specification be forwarded to Alderman Jardine and tenders called.

675. Resolved that the question of completion of Mr Reda's contract be referred to Councilor McKee & the Engineer

688. Resolved that the assessment commence on Monday February 21st and finish on Saturday April 23rd.

689. W Mergel addressed the Council with reference to his wages due on M. Johansen's contract.

690. Resolved that the Clerk write owners of Blocks 11, 12 & 13. D & 95 requesting them to adjust their survey in accordance with Mess^{rs} Mullik and Attes fence which was erected in accordance with the original survey posts then in evidence on the ground.

691. Moved by councillor Rumble seconded by councillor McKee that the Board of Works be given power to put option not to exceed \$500 on land for gravel pit on the South side of the Vancouver

Road.
