A special meeting of the Burnaby Council was held in the Burnaby Municipal Hall on Thursday evening at 7.30 p. m. Present his Worship Revere Byrne and Couns. Stride, Coldecutt, Mr. Kee, With and Quimble.

1183 Moved by Coun. Quimble seconded by Coun. Stride that the minutes of the previous meeting be dispensed with.

1184 Road Tax. applications for the position of Road Tax collector were received from Messrs Jno. Green & R. Pontefex. It was decided that the Revere see and arrange matters with Mr. J. Green.

1185 North Road Crossing. Mr. J. Smith, C.M.C. of Coquitlam Municipality wrote asking for the Burnaby delegates to the Board of Railway Commissioners arrange a time to meet Revere Welder & Coun. Cameron of Coquitlam and take the question over. Moved by Coun. Quimble seconded by Coun. Stride that this Council is in favor of:-
(1) Plan No. 2 which shows a diversion of the road and that the high bridge is to be a steel structure.
(2) That all parties be assessed equably for the payment of same. ^{Mr. Coldecutt rose against.} ^{These first two. The rest of Council were in favor of them.}
It was also decided that the Revere & Coun. Coldecutt should meet the Coquitlam delegates at the Hall at 10 o'clock on Sat. Sept 3rd & report back to the Council.
