3 An Adjourned Meeting of the Council was held at the Municipal Hall on  
4 Thursday, July 6th. inst. at 8 o'clock p.m.  
5 Present :- Councillors Mac Donald, Rumble, Coldicutt, and Stride.  
6 Moved by Cr. Coldicutt, Seconded by Cr. Stride :- "That Councillor Mac Donald  
7 do take the Chair." Carried unanimously.  
8 Moved by Cr. Coldicutt - Seconded by Cr. Rumble :- "That further consideration of  
9 the Western Canada Power Company Limited Light & Power (Burnaby) By Law, 1911  
10 be deferred until Monday 10th. inst." Carried unanimously.  
11 Mr. Ida. Fearn applied for a Release of the Mortgage on Blk. 5 D. 2. 91.  
12 Moved by Cr. Coldicutt, Seconded by Cr. Rumble :- "That the Solicitors  
13 be instructed to prepare a Release" and that it be signed by the Reeve  
14 and Clerk and sealed with the corporate Seal."  
15 Carried unanimously.  
16 The Solicitors submitted a <sup>draft</sup> Petition to the Lieut. Governor for a 6' road  
17 allowance from Paterson Rd. to Vancouver Rd. parallel to B.C. Ry.  
18 Moved by Cr. Coldicutt - Seconded by Cr. Rumble :- "That the Petition be  
19 signed by the Reeve." Carried unanimously.  
20 Moved by Cr. Coldicutt - Seconded by Cr. Rumble :- "That the Burnaby  
21 Debenture Advance By Law 1911 be introduced and read a First time  
22 Carried unanimously  
23 Moved by Cr. Coldicutt - Seconded by Cr. Rumble :- "That the Burnaby  
24 Debenture Advance By Law 1911, do pass the First reading".  
25 Carried unanimously  
26 Moved by Cr. Coldicutt - Seconded by Cr. Rumble :- "That the Burnaby  
27 Debenture Advance By Law 1911, be read a Second time".  
28 Carried unanimously  
29 Moved by Cr. Coldicutt - Seconded by Cr. Rumble :- "That the Burnaby  
30 Debenture Advance By Law 1911, do pass the Second Reading".  
31 Carried unanimously  
32 Moved by Cr. Coldicutt - Seconded by Cr. Rumble :- "That Mr Stride be  
33 allowed to close Henry Street West from Humphrey Avenue, temporarily,  
34 at the will and pleasure of the Council." Carried unanimously.  
35 The Council then adjourned.
