

Monday - March 18th. 1912

1 An Adjourned Meeting of the Council was held at the Municipal  
2 Hall on Monday, March 18th. 1912, at 8 o'clock p.m.

3 Present: - His Worship Reeve Weart

4 Councillors Faulvel, Mayne, Madill, McGregor and Mac Donald.

5 Moved by Cr. Mac Donald. Seconded by Cr. Madill, and.

6 Resolved: - "That the Council lend to M. B. Anthony and Company,  
7 of Vancouver, the sum of Five Thousand Dollars (\$5000) from  
8 the Sinking Fund, for a period of Three (3) years, the repayment  
9 of which sum, together with Interest thereon at the rate of  
10 Six (6) per. centum per. annum, being secured by a First  
11 Mortgage on Real Property held and used for farming purposes  
12 by the said M. B. Anthony and Company, and described as  
13 Lots 7, 8, 9, 10, 15, 16, 17, 18, 23, 24, 25, 26, 31, 32, 33, 34, 39, 40, 41, 42,  
14 44, 48, 49, 50, 55, 58, 63, 64, 82, 83, 86, 87, 90, 91, 95, 96 and 97, of  
15 Block (4) Seven, District Lot Eighty seven (87) Group One, New  
16 Westminster district, the same being assessed, together with  
17 the buildings and improvements thereon, at the total sum of  
18 Thirteen Thousand, One Hundred and Twenty five Dollars,  
19 (\$13,125.00), according to the last revised and corrected  
20 Assessment Roll of the Municipality"

21 Carried unanimously.

22 Moved by Cr. Mac Donald. Seconded by Cr. Madill, and

23 Resolved: - "That the Council lend to W. J. Walker, of Burnaby  
24 Lake, the sum of Five Hundred Dollars (\$500.00) from the  
25 Sinking Fund, for a period of Three (3) years, the repayment  
26 of which sum, together with Interest thereon, at the rate of  
27 Six (6) per. centum per. annum, being secured by a First Mortgage  
28 on Real Property held and used for farming purposes by the  
29 said W. J. Walker, and described as 429 acres in Block Seven (7)  
30 District Lot Eighty five (85) Group One, New Westminster district,  
31 the same being assessed, together with the buildings and  
32 improvements thereon, at the total sum of Two Thousand, Five  
33 Hundred and Ninety-five Dollars (\$2595.00), according to  
34 the last revised and corrected Assessment Roll of the  
35 Municipality."
