A Regular Meeting of the Council was held at the Municipal Hall on Monday - September 8th. 1913. at 8.30 O'clock. p.m.

Present: - His worship Reeve Mc. Gregor.

Councillors Mac. Donald, Macpherson, Van Vel, Coldicutt, and Stride.

Moved by Cr. Van Vel. Seconded by Cr. Coldicutt: - "That the Minutes of the Meetings of August 18th. and 25th ulto. and September 2nd. inst. be adopted as typewritten, and confirmed."

Carried unanimously.

Correspondence was received and dealt with as follows:-

District Registrar of Titles - re. Map 1922, and Maps. 1439 & 2223.

advising that it would be obligatory on his part to issue title to 3 lots or smaller portions, and that it was incumbent on the Municipality to provide for the enforcement of the provisions of the Maps Approval By Laws.

Moved by Cr. Macpherson. Seconded by Cr. Mac. Donald: - "That the thanks of this Council be conveyed to the Registrar for the information supplied, and that he be informed that when possible in the future, such steps will be taken as will protect the interests of this Corporation."

Solicitors. re. Subdivision Plan of Blocks 5 and 6 and portion of Block 8, D. L. 90., asking for further instructions as to the form of Bond &c.

Moved by Mr. Macpherson. Seconded by Mr. Stride:- "That the matter be left in the hands of the Solicitors, and they be instructed to take such steps as will absolutely protect the interests of this Corporation herein."




