7 Murray.

8 Moved by br. Faw Vel, seconded by br. Allen: "That this
9 Council do now resolve into a Committee of the Whole
10 to reconsider the Burnaby Revenue By-Law 1914."

11 Carried unanimously.

12 Moved by br. Faw Vel, seconded by br. Allen: "That the
13 Committee do now rise, and report the By-Law complete."

14 Carried unanimously.

15 Moved by br. Macdonald, seconded by br. Rose: "That the
16 Burnaby Revenue By-Law 1914 be read a Third time."

17 Carried unanimously.

18 Moved by br. Faw Vel, seconded by br. Rose: "That the
19 Burnaby Revenue By-Law 1914 do now pass the Third
20 reading, that it be signed by the Reeve and Clerk and
21 the Corporate seal be affixed thereto."

22 Carried unanimously.

23 Moved by br. Macdonald, seconded by br. Rose: "That
24 this Council do now resolve into a Committee of the
25 Whole to reconsider the Burnaby School Board (Extra-
26 Municipal) Revenue By-Law 1914."

27 Carried unanimously.

28 Moved by br. Faw Vel, seconded by br. Macdonald: "That
29 the Committee do now rise, and report the By-Law complete"

30 Carried unanimously.

31 Moved by br. Macdonald seconded by br. Faw Vel: "That
32 the Burnaby School Board (Extra-Municipal) Revenue
33 By-law 1914 be read a Third time."

34 Carried unanimously.

35 Moved by br. Faw Vel, seconded by br. Rose: "That the
36 Burnaby School Board (Extra-Municipal) Revenue By-Law
37 1914 do pass the Third reading, that it be signed by
38 the Reeve and Clerk, and the Corporate Seal be
39 affixed thereto."

40 Carried unanimously.

41 The Manager, Royal Bank of Canada wrote asking that the
42 Bank form for Signing Officer for School Board By-Law
43 Account might be executed by this Corporation.

44 Moved by br. Faw Vel, seconded by br. Macdonald: "That

1 the Treasurer, Mr. Bolton, he and is hereby authorized
2 to sign cheques for the release of School Board By-Law
3 monies, and that the Bank form be signed by the
4 Reve and clerk, and that the corporate seal be
5 affixed thereto.

6 *Carried unanimously.*
7 The London Guarantee & Accident Co. wrote asking for a
8 refund of \$100.00. which they had paid to the Chief
9 Constable as expenses in the matter of bringing J. V. Currell
10 from Calgary.

11 Moved by Mr. Fawcett seconded by Mr. Rose. That the matter
12 be referred to the Corporation Solicitors to advise.
