3 An Adjourned Meeting of the Council was held at the  
4 Municipal Hall on Monday, November 9th. 1914, at 9 o'clock p.m.  
5 Present:- His Worship Reeve Fraser

6 Councillors Mac. Donald, Van Vel, Murray, Allen, and Bevan.

7 The Manager of the Royal Bank wrote re. Temporary Loan No. 3  
8 By Law 1914, advising that the Solicitors of the Bank  
9 required the By Law to be for \$100,000 instead of \$200,000,  
10 as originally proposed, the \$100,000 remaining unpaid under  
11 Temporary Loan No. 2, to remain as an Overdraft.

12 Moved by Cr. Mac. Donald, Seconded by Cr. Murray:- "That this  
13 Council do now resolve into a Committee of the Whole to  
14 reconsider the Burnaby Temporary Loan No. 3, By Law, 1914."  
15 Carried unanimously.

16 Moved by Cr. Allen, Seconded by Cr. Van Vel:- "That the By Law  
17 be amended to read \$100,000 instead of \$200,000 as the  
18 amount to be borrowed.

19 Carried unanimously.

20 Moved by Cr. Mac. Donald, Seconded by Cr. Allen:- "That the  
21 Committee do now rise and report the By Law complete  
22 as amended."

23 Carried unanimously.

24 Moved by Cr. Mac. Donald, Seconded by Cr. Bevan:- "That the  
25 Burnaby Temporary Loan No. 3, By Law 1914, be read a Third time  
26 Carried unanimously.

27 Moved by Cr. Bevan, Seconded by Cr. Mac. Donald:- "That the  
28 Burnaby Temporary Loan No. 3 By Law 1914, do pass the Third  
29 Reading, that it be signed by the Reeve and Clerk, and  
30 the Corporate Seal be affixed thereto."

31 Carried unanimously.

32 Moved by Cr. Mac. Donald, Seconded by Cr. Murray:- "That the Hastings-  
33 Barnet Road Diversion By Law, 1914, be now reconsidered by  
34 this Council as a Committee of the Whole."

35 Carried unanimously.

36 Moved by Cr. Mac. Donald, Seconded by Cr. Allen:- "That the Committee  
37 do now rise and report the By Law complete, without amendment.

39 Moved by Cr. Mac. Donald, Seconded by Cr. Bevan:- "That the  
40 Hastings-Barnet Road Diversion By Law 1914, be read a Third time

42 Moved by Cr. Mac. Donald, Seconded by Cr. Murray:- "That the  
43 Hastings-Barnet Road Diversion By Law 1914, do pass the Third  
44 Reading, that it be signed by the Reeve and Clerk, and

1 the corporate Seal be affixed thereto.
