

Monday, August 28th. 1916.

A Regular Meeting of the Council was held at the Municipal Hall on Monday, August 28th. 1916, at 7.10 p.m.

Present: - His worship Reece Jones.

Councillors Mac.Donald, Coldicutt, Holdom, and Murray,
 Moved by Mr. Coldicutt, Seconded by Mr. Holdom: - "That the Minutes of the Meetings of August 14th. and 21st. insts. be adopted as written and confirmed;"

Carried unanimously.

Correspondence was received and dealt with as follows: -

Solicitors - re. North Road and V.I. & E. Ry. enclosing copy of the Order No. 25260, of the Board of Railway Commissioners, herein.

Moved by Mr. Coldicutt, Seconded by Mr. Murray: - "That a Committee, consisting of the Reeve, with Mr. Mac.Donald and the Engineer be appointed to make arrangements for such further details as may be necessary."

Inspector of Legal Offices re. Special Survey No. 3. advising that the Plans herein have been filed by the Surveyor, and suggesting that Blue Prints be deposited in the Land Registry Office, Vancouver, in addition to those deposited as required by statute.
