2 A Regular Meeting of the Council was held at the
 3 Municipal Hall on Monday, July 31st. 1916, at 4.30 p.m.
 4 Present:- His worship Reeve Fraser.

5 Councillors Mac Donald, Murray, Coldirett, Green and
 6 Holdom.

7 Moved by Mr. Coldirett, Seconded by Mr. Holdom: "That the
 8 Minutes of the Meeting of July 14th. be adopted as written,
 9 and confirmed."

10 Carried unanimously.

11 Correspondence was received and dealt with as follows:-
 12 Lt. Col. Taylor re. Alta Vista Post Office

13 Post Office Inspector re. do.

14 Moved by Mr. Coldirett, Seconded by Mr. Holdom: "That the
 15 letters be received, and copies thereof be sent to the
 16 Petitioners from Alta Vista."

17 Carried unanimously.

18 Burnaby Record - re. Tax Sale advertising; asking that
 19 the award of the tender be reconsidered.

20 Moved by Mr. Mac Donald, Seconded by Mr. Murray: "That the
 21 letter be received and filed".

22 Carried unanimously.

23 Secretary U.B.C.M. re. Annual Convention, and asking that
 24 the Membership Fee, \$50, be paid as soon as possible.

25 Moved by Mr. Coldirett, Seconded by Mr. Mac Donald: "That the
 26 letter be received, the date of the convention noted,
 27 and a cheque for the amount of the subscription be sent
 28 as soon as possible."

31 Finance Committee Reports:- Your committee met on
 32 July 14th. 1916, and recommend:-

- 33 1. That the printing of Tax Sale forms be awarded to

 Co. at 55 cents. per. inch.

35 Your committee met on July 24th. 1916, and recommend:-

Water Committee Report: -

Your Committee met on July 24th. 1916, and recommend:-

1. That the Estimate of Work for the two weeks commencing July 21st., amounting to \$502.50, be adopted.

2. That the Expenditure incurred during the two weeks ended July 24th., amounting to \$148.45, be approved.

3. That a water service be laid to Block 1. D.L. 127.

4. That the recommendation of the Engineer, re. reinforcing 18in. main on Royal Oak Avenue, be adopted.

5. That the matter of Capitol Hill water supply, lay over pending the receipt of a petition for the execution of the works, under the Local Improvement plan.

6. That the water account to March 1st. 1916, on the Gray Block, be reduced to the rate for average consumption.

Moved by Cr. Murray. Seconded by Cr. Holdom: - "That the Report of the Water Committee be adopted."

Carried unanimously.

Police, Light and Fire Committee Report:

Your Committee met on July 24th. 1916, and recommend:-

1. That the application of the B.C. Telephone Co., for underground pipe crossings on Sperling Avenue, as per drawing No. A 5092, be granted.

Moved by Cr. Oldfield, Seconded by Cr. Holdom: - "That the Report of the Police, Light and Fire Committee, be adopted."

Carried unanimously.

Board of Works Report: -

Your Committee met on July 24th. 1916, and recommend:-

1. That the Estimate of Work for the two weeks commencing July 24th., amounting to \$1480, be approved.

2. That the Expenditure incurred during the two weeks ended July 14th., amounting to \$11.45 be approved.

3. That the Vancouver and Districts Joint Sewerage and Drainage Board be notified of the obstructions existing

1 in the Baunette River.

- 2 4. That the tender of J. G. Ettinger and A. R. Attoe, at \$425,
 3 for the construction of a bridge on Johnston Road, be
 4 accepted.
- 5 5. That the tender of the Columbia Bitulithic Ltd., at
 6 \$4045.25, for repairs and squeeze coat to Kingsway
 7 pavement, be accepted.

8 Moved by Mr. Green, Seconded by Mr. Mac Donald: - "That the
 9 Report of the Board of Works be adopted."
 10 Carried.

11 Mr. Holdom objecting to items 4 and 5.

12 Moved by Mr. Coldicutt, Seconded by Mr. Murray: - "That the
 13 Agreement between this Corporation and the Canadian Mineral
 14 Rubber Co., and the Canadian Bank of Commerce, re.
 15 cash guarantee for maintenance of Kingsway pavement; be
 16 signed by the Reeve and the Clerk, and that the Corporate
 17 Seal be affixed thereto."

18 Carried unanimously.

19 Moved by Mr. Coldicutt, Seconded by Mr. Green: - "That the contract
 20 with the Columbia Bitulithic Ltd. for repairs and squeeze
 21 coat to Kingsway pavement, be signed by the Reeve, and
 22 the Clerk, and that the Corporate Seal be affixed thereto."

23 Mr. Holdom, against, Carried unanimously.

24 Moved by Mr. Mac Donald, Seconded by Mr. Coldicutt: - "That
 25 the contract with J. G. Ettinger and A. R. Attoe for the
 26 construction of a Bridge on Johnston Road, be signed by
 27 the Reeve and the Clerk, and that the Corporate Seal be
 28 affixed thereto."

29 Carried.

30 Mr. Holdom against.

31 Mr. Mac Donald mentioned the fact that the applicants
 32 who requested permission to erect a Bath house on the
 33 Street end of Madison Avenue, were erecting it on C. P. R.
 34 property, and he further advised that the Company would
 35 allow the building to remain, if application thereto, was
 36 made by this Corporation.

37 Moved by Mr. Coldicutt, Seconded by Mr. Mac Donald: - "That the
 38 C. P. R. Co. be informed that this Corporation will have no
 39 objection to the use of the foreshore being granted by the
 40 Company to the applicants."

41 Carried unanimously.

42 Moved by Mr. Coldicutt, Seconded by Mr. Green: - "That this Council
 43 do now adjourn."
