 4 Hall on Monday, June 5th, 1916, at 4 o'clock p.m.

5 Present: His worship Reeve Fraser.

6 Councillors MacDonald, Coldicutt, Murray, Bevan, Holdom,
 7 and Green.

8 Moved by Cr. Mac Donald, Seconded by Cr. Coldicutt: - That the
 9 Minutes of the Meeting of May 22nd, be adopted as written,
 10 and confirmed.

11 Carried unanimously.

12 Correspondence was received and dealt with as follows:-
 13 Secretary, School Board, re. Rent to Central Park Agricultural
 14 Association, enclosing copy of a letter to the Board, from
 15 W. Kirkham.

16 Moved by Cr. Mac Donald, Seconded by Cr. Bevan: - That the
 17 letter be received and filed.

18 Carried unanimously.

19 Secretary, W. B. C. H., re. Telephone Rates, Tolls, and Charges,
 20 enclosing copies of Resolutions passed by the Executive
 21 on May 30th.

22 Moved by Cr. Murray, Seconded by Cr. Mac Donald: - That the
 23 letter be received, and that the resolutions be endorsed
 24 and referred to the Reeve with Cr. Mac Donald and the
 25 Clerk, with power to act.

35 Finance Committee Report: - Your Committee met on May

5. That a Stand-pipe be installed on the south side of Beresford Street.
6. That \$2. be written off the water rate account, Central Park Presbyterian Church.

Health, Hall and Grounds Committee Report.

Police, Light and Fire Committee Report.

Your Committee met on May 29th. 1916, and recommend:-

1. That the application of the B. C. Telephone Co. for pole locations in the Central Park district, be referred to the Municipal Engineers to go over the ground, and report.
2. That the application of the Western Canada Power Co., for pole locations for 14,000 volt line on the north side of Johnston Road, and on Laniboo Road, be referred back for further detailed plans.

Moved by Mr. Goldieatt, Seconded by Mr. Holdom: - "That the Report of the Police, Light and Fire Committee, be adopted." Carried unanimously.

Board of Works Report.

Your Committee met on May 29th. 1916, and recommend:-

1. That the Estimate of Work for the two weeks commencing June 5th., amounting to \$2,158, be adopted.
2. That the Expenditure incurred during the two weeks ended May 20th., amounting to \$11.85, be approved.
3. That the Report of the Engineer on Applications, be adopted.
4. That D.L. 143 Ltd. be notified that the ^{title to the} so called "Spur" area D.L. 143, is vested in the Crown, and that the land is held by this Corporation for Street purposes.
5. That this Council take no action in connection with the registration of the North half of Lot 2, Blk. 55, D.L. 55.
6. That the Engineers confer with the Western Canada Power Co. with regard to Beta Avenue, and refer to the terms of the By Law, with reference to this road.

Moved by Mr. Bevan, Seconded by Mr. Macdonald: - "That the Report of the Board of Works be adopted."

Carried unanimously.

Moved by Mr. Bevan, Seconded by Mr. Goldieatt: - "That the Clerk write, asking the Provincial Government for an appropriation of \$400 to repair and oil Riverway through D.L. 143." Carried unanimously.

1 Council goes on record as showing its appreciation of the
2 gallant fight and splendid showing of the British Navy
3 in the battle off Jutland, and tender its sincere
4 condolence and sympathy to the relatives of the brave
5 men who sacrificed their lives for freedom and the
6 Empire, and that a copy of this resolution be cabled
7 to the British Admiralty.


