

Monday May 17th. 1926.

An adjourned meeting of the Council was held at the Municipal Hall on Monday, May 17th. 1926 at 7.30 p.m.

Present: His Worship Reeve McLean in the chair.

Councillors Smith, Gray, Hall, Moore, Planche, Bell & Engberg.

Correspondence was received and dealt with as follows:

1. G. Kilshaw, on behalf of the Canadian Legion, alleging that returned soldiers were being discriminated against in the matter of employment in the Municipality of Burnaby.

Moved by Cr. Bell, Seconded by Cr. Hall: "That the letter be received and filed and that further particulars be requested."

Carried unanimously.

2. Reid, Wallbridge and Gibson submitting on behalf of one A. McLellan a claim for \$1,225.00 for loss of building and contents by fire alleged to have been caused by negligence of Municipal employees.

Moved by Cr. Smith, Seconded by Cr. Moore: "That this matter be referred to a special committee of the Chief of Police, Reeve McLean and the Chairman of the Board of Works."

3. Chief Commissioner, Greater Vancouver Water District, advising that the application of the Corporation of Point Grey to store water in Upper and Lower Palisade Lakes is now taken over by the Water District and asking that objection of this Corporation to the application be withdrawn.

Moved by Cr. Moore, Seconded by Cr. Engberg: "That the request of the Commissioner be acceded to and the objection of this Corporation withdrawn"

McMurray, Bros, and Doran alleging discrimination in matter of obtaining trucking work and asking that in future they be given an equal share of the work available.

Moved by Cr. Smith, Seconded by Cr. Hall: "That in view of the seniority of Messrs McMurray and Doran that they be given a share of the Municipal trucking."
