His Worship Reeve McLean and the Engineer submitted a recommendation that this Corporation undertake the work of constructing 260° of roadwork on Boundary Road in order to link up the Vanc over section of the Grandview Highway with the Burnaby section.

Moved by Cr. Engberg, Seconded by Cr. Smith: "That the recommendation of the C. numittee be adopted."

His Worship Reeve McLean submitted a report re Sewer Connections and recommended

that someone be appointed to supervise the making of connections and that connections be made by the Corporation.

Moved by Cr.Planche, Seconded by Cr.Gray: 'That the foreman in charge of Ward 5 Board of Works gang be appointed as Sewer Inspector for the Ward 5 district."

empowered to employ applicant for Sewer Connections to dig the trench provided he is satisfied that said applicant is capable and that the cost does not exceed \$7.44 for a lane connection and \$11.94 for a connection to the sewer on the street."

Moved by Cr. Smith, Seconded by Cr. Engberg: "That this Council do now resolve into a committee of the whole with the Reeve in the Chair to reconsider the Burnaby Sewer Connections Regulation By-lew 1926. Amendment By-law 1926."

The Treasurer submitted a letter advising that expenditure of monies for Waterworks extensions recently authorised was not in order and protesting against such expenditure.

Moved by Cr. Engberg, Seconded by Cr. Gray: "That the letter be received and filed."

Carried unanimously.

Moved by Cr. Smith, Seconded by Cr. Hall: "That this Council do now adjourn."
