Ward 5 Ratepayers Association wrote re Lots32 and 33, Block 8 D.L.122. Moved by Cr.Moore, Seconded by Cr.Planche: "That these lots be reserved for possible fire hall purposes and that R.P.Clark and Co (Vancouver) Ltd. be so notified."

Carried unenimously,

North Burnaby Board of Trade wrote suggesting that a 10% first payment be accepted on sales of Corporation property instead of the 25% as now in force. R.P.Clark and Coy (Vancouver) Ltd. also wrote endorsing this proposal. Moved by Cr.Moore, Seconded by Cr.Lambert: "That a first payment of 10% be accepted on sales of Corporation tax sale property up to October 31st 1927 and that after that date the 25% first payment be resumed."

Moved by Cr.Mcore, Seconded by Cr.Planche: "That this Council do now adjourn until Monday July 25th.1927 at 7.30 p.m. "
