

Monday - September 17th. 1928.

A Regular meeting of the Council was held at the Municipal Hall on Monday, September 17th. 1928 at 7.30 p.m.

Present: His Worship Reeve McLean in the chair.

Councillors West, Gray, Lambert, Pritchard, Planche, Shewbrooks and Wilson.

Moved by Cr.Pritchard, Seconded by Cr.Gray: "That the minutes of the meetings of August 27th ult. and September 4th inst. be adopted as written and confirmed."

Carried unanimously.

Correspondence was received and dealt with as follows:

W.Grimes, Moscrop Area Ratepayers requesting the delegates to the Union of B.C.Municipalities to press for amendment to the Municipal Act making Municipal Corporations liable for damage resulting from accidents to persons arising out of the condition of wooden sidewalks.

Moved by Cr.Gray, Seconded by Cr.Pritchard: "That the letter be received and filed."

Carried unanimously.

Messrs McQuarrie, Whiteside & Duncan - forwarding copy of letter of Registrar of the Board of Railway Commissioners re sitting of the Board.

Moved by Cr. Gray, Seconded by Cr.Pritchard: "That the letter be received and filed."

Carried unanimously.

Messrs McQuarrie, Whiteside and Duncan - advising that the Corporation were not liable under the Sheep Protection Act for damages claimed for by Mrs.Elizabeth Andrews, and suggesting that Mrs.Andrews apply to the Minister of Agriculture for leave to file with him a claim.

Pritchard, Seconded by Cr.West: "Whereas an offer to purchase Lot "E" of D.L.217, Group 1. from this Corporation was made by the Riverview Land Co. subject to certain conditions made and set forth in letters from the said Riverview Land Co. under dates February 6th and February 21st 1928 and the said offer and conditions were accepted and approved by the Municipal Council on the 25th day of February, 1928 AND WHEREAS the said Company has not fulfilled the said conditions: THEREFORE BE IT RESOLVED:

"That the negotiations with the Riverview Land Co. for the sale of Lot "E" D.L.217. Group 1. be and they are hereby cancelled, unless the sum of \$5,000.00 is deposited by the said Company with the Municipal Treasurer on or before the 20th day of September, 1928."

Messrs Killam and Beck w requesting the assistance of the Council in the matter of restrictions on buildings in the subdivision recently purchased by the Burnaby Lands Limited.

Moved by Cr.Gray, Seconded by Cr.Wilson: "That the letter be received and filed and that they be informed that this Council is sympathetic towards this matter and that a Committee of His Worship the Reeve, Councillors Wilson and Pritchard be appointed to further consider this matter."

West: "That this matter be again taken up with the South Vancouver Council asking if they are in favor of pressing for the paving of Boundary Road and also asking that a Committee be appointed to interview the City Council of Vancouver along with a Committee from this Council."
