

Thursday March 8th. 1928.

An adjourned meeting of the Council was held at the Municipal Hall on Thursday, March 8th. 1928 at 7.30 p.m.

Present: His Worship Reeve McLean in the chair.

Councillors West, Gray, Lambert, Pritchard, Planche, Shewbrooks and Wilson.

The Building Inspector submitted an application of Mr. Mellish for permission to keep 400 head of poultry on Lots 10 and 11, Block 8, D.L. 94. and recommended that permission be so granted.

Moved by Cr. West, Seconded by Cr. Lambert: "That the recommendation be adopted."

Carried unanimously.

B.C. Nurseries Coy. Ltd. submitted an application for permission to cut Kingsway kerb opposite Block 3, D.L. 32.

Moved by Cr. Gray, Seconded by Cr. West: "That permission be granted subject to the work being done to the satisfaction of the Engineer and on the understanding that the boulevard is to be used for parking purposes only."

Carried unanimously.

The Engineer submitted a plan of proposed connection pipes to the Greater Vancouver District Reservoir and recommended approval be given. Moved by Cr. Gray, Seconded by Cr. Lambert: "That the recommendation of the Engineer be adopted subject to an undertaking from the Board to replace road surfaces in original condition."

Carried unanimously.

G. Conway Brown wrote inviting the Council to attend a Mass meeting on Friday March 8th. inst. at 8. p.m.

Moved by Cr. West, Seconded by Cr. Shewbrooks: "That the invitation be accepted."

Carried unanimously.

Cr. Lambert gave notice of motion to introduce an amendment to the Building By-law to provide for other than 8 inch concrete walls.

The Engineer submitted schedule of work proposed to be done under the Waterworks Extension Loan By-law amounting to \$196,689.20

Moved by Cr. Shewbrooks, Seconded by Cr. West: "That the report be received."

Carried unanimously.

Moved by Cr. Pritchard, Seconded by Cr. Wilson: "That the amount of the proposed by-law be raised to \$200,000.00 in order to make provision for cost of repairs to main on Hastings Earnet Road."

Carried unanimously.

Moved by Cr. Shewbrooks, Seconded by Cr. West: "That the Burnaby Waterworks Extension Loan By-law 1928 be introduced and read a first time."

Carried unanimously.
