

Tuesday - April 22nd.1930.

A Regular meeting of the Council was held at the Municipal Hall on Tuesday, April 22nd.1930 at 7.30 o'clock p.m.

Present: His Worship Reeve Pritchard.

Councillors Smith, Shaw, Lambert, Edwards, Wheatley, Shewbrooks and Wilson.

Moved by Cr.Smith, Seconded by Cr.Wheatley: "That the minutes of the meetings of April 7th, 14th and 16th insts. be adopted as written and confirmed."

Carried unanimously.

Correspondence was received and dealt with as follows:

His Worship Reeve Pritchard - advising that the Shell Oil Company of British Columbia were now prepared to purchase from this Corporation Block B D.L. 217.

Moved by Cr.Smith, Seconded by Cr.Wheatley: "That the letter be received and filed and that a copy of same be supplied to each member of the Council."

Carried unanimously.

Messrs Whiteside, Wilson & White - further to their letter of February 21st ultimo - advising that they were now prepared to complete the purchase of D.L. 217.B. for their clients the Shell Oil Company of British Columbia subject to certain arrangements being made and subject to the Company being able to obtain riparian rights on Burrard Inlet.

- (2) To weld all joints in steel pipe and braze all joints steel to cast iron at a cost of \$1200.00 including digging bell holes pumping, etc.

The Engineer recommended method No.1.
