Carried unanimously.

The Assessor submitted return showing assessment for the year 1930 as amended and confirmed by the Court of Revision, showing Total taxable land at \$10,637,250.00 and Total value of taxable improvements at \$11,641,602.00

Moved by Cr.wilson, Seconded by Cr.Smith: "That the statement be received and filed and a copy of same be supplied to each Councillor." Carried unanimously.

Moved by Cr. Edwards, Seconded by Cr. Wheatley: "That the Burnaby Town Planning Commission By-law 1930 be introduced and read a first time." Carried unanimously. Moved by Cr. Edwards, Seconded by Cr. Smith: "That the Burnaby Town Planning

Commission By-law 1930 do pass the first reading. Carried unanimously.

Moved by Cr. Edwards, Seconded by Cr. Wheatley: "That the Burnaby Town Planning

Commission By-law 1930 be now read a second time. Moved by Cr. Edwards, Seconded by Cr. Wheatley: "That the Burnaby Town Planning Commission By-law 1930 do pass the second reading.
