

Monday August 4th. 1930.

An adjourned meeting of the Council was held at the Municipal Hall on Monday, August 4th. 1930 at 7.30 p.m.

Present Reeve Pritchard in the Chair: Councillors Smith, Shaw, Edwards Lambert, Wheatley, Shewbrooks.

The Reeve submitted a recommendation:- "That Councillor T. E. Wilson be granted two weeks leave of absence from this date, and that Councillor F. E. Shaw be authorized to act in his stead."

Moved by Cr. Edwards, Seconded by Cr. Wheatley:- "That the recommendation of the Reeve be endorsed."

Carried unanimously.

Moved by Cr. Lambert, Seconded by Cr. Shaw: "That this Council do now resolve into a committee of the whole with the Reeve in the Chair to reconsider Local Improvement Construction By-law No. 34, 1930."

Carried unanimously.

Moved by Cr. Lambert, Seconded by Cr. Edwards:- "That the Committee do now rise and report the By-law complete without amendment."

Carried unanimously.

The Council re-convened

Moved by Cr. Lambert, Seconded by Cr. Smith:- "That Local Improvement Construction By-law No. 34, 1930 be now read a Third time."

Carried unanimously.

Moved by Cr. Lambert, Seconded by Cr. Edwards:- "That Local Improvement Construction By-law No. 34, 1930 do pass the third reading, that it be signed by the Reeve and the Clerk and that the corporate seal be affixed thereto."

Carried unanimously.

Moved by Cr. Lambert, Seconded by Cr. Wheatley:- "That the Engineer be and is hereby authorized to construct the sewer as provided by the Local Improvement Construction By-law No. 34, 1930."

Carried unanimously.

The Clerk reported "That there were 69 owners representing \$44,650.00 of assessed value within the proposed Carleton Avenue Sewer area and that objections had been received from five owners representing \$1,590.00 of assessed value, and that as the number of objections was less than the number required under the provisions of the Local Improvement Act it would be in order to proceed with the proposed works.

Carried unanimously.

Moved by Cr. Wheatley, Seconded by Cr. Lambert, "That the Clerk be instructed to prepare the necessary construction by-law."

Carried unanimously.

Dr. J. W. McIntosh wrote requesting leave of absence to attend the Convention of the British Medical Association and the Canadian Medical Association at Winnipeg.

Moved by Cr. Smith, Seconded by Cr. Lambert:- "That the request of the Medical Health Officer be requested.

Carried unanimously.

Mrs. J. S. Driver wrote asking that the provisions of the Town Planning By-law be waived to permit of the operation of a grocery store at 657 - 12th. Avenue.

Moved by Cr. Smith, Seconded by Cr. Lambert:- "That the application be granted."

Carried unanimously.

Moved by Cr. Edwards, Seconded by Cr. Smith:- "That the meeting do now adjourn."
