"

Messrs McQuarrie, Whiteside and Duncan - advising that by order of Mr. Justice McDonald, George A Grant had been appointed Commissioner for the Capitol Hill re-plotting scheme. Moved by Cr. Wilson, Seconded by Cr. Pylett: "That the letter be received and filed."

George A Grant - advising his acceptance of position as Commissioner and advising that he had set the Municipal Hall Edmonds as the place for holding enquiry and hearing complaints and 10 o'clock a.m. on June 23rd 1931 as the time and hour. Moved by Cr.Rylett, Seconded by Cr.Wilson: "That the letter be received and filed. Carried unanimously.

. Furnaby Werkers Protective Association - presenting the following demands
