The works to be undertaken to be those, the incompletion of which are liable to constitute a public nuisance.

The Engineer recommended that this work of grubbing be undertaken and that the claim be settled as above. The Local Assistant Fire Marshal submitted report recommending that an old delapidated garage presently situate on Lot 7, Block 18, D.L.121. be dismantled and the debris be burnt or otherwise disposed of.

Martin: "Whereas from time to time I have expressed my own dissatisfaction withthe administration of the Relief Department - Whether I look at it from the position of the Poor and Needy, or from the Taxoayers point of view, or from the standpoint of the Grocers who are carrying this Municipality. From whichever point I look at it there is cause from grave dissatisfaction. Since the last meeting of this Council held on Wednesday last I am convinced that meeting of this Council held on Wednesday last I am convinced that there is no hope of us arriving at an agreement on a definite sane policy for administration and carrying out of our responsibilities and duty toward the parties concerned. We have had an investigation into certain activities of the Relief department, by this Council sitting as a Committee of the whole. The outcome was very unsatisfactory. The situation in this Council offers little hope of our arriving at a satisfactory solution of our problem. The position is repaidly getting worse I consider the following motion appropriate under these circumstances:

BE IT RESOLVED THEREFORE on account of the dissatisfaction existing within this Council, resulting from an investigation into courties. within this Council, resulting from an investigation into certain activities of the Relief Department by this Council sitting as a Committee of the whole that we do arrange for an independent investigation and that we approach the Inspector of Municipalities and request his assistance in securing theservices of a suitable party for this purpose. Negatived - Crs. Wheatley, Lambert, Hatherly and Reeve Pritchard voting against.

Moved by Cr.Martin, Seconded by Cr.Brown: "That Whereas the present depression is the result of conditions world wide in extent; AND WHEREAS depression is the result of conditions world wide in extent; and whereas it has been admitted and recognized by the Dominion Government of Canada to be a national crisis asfar as Canada is concerned; AND WHEREAS the Burnaby Council has repeatedly gone on record as in agreement withthe above; AND WHEREAS Burnaby with its limited means of taxation and resources is unable to continue to pay its share of the present system of direct relief. THEREFORE BE IT RESOLVED that this Council notify the Provincial Government that it is unable to carry on under the present system beyond the date of August 15th. 1932 and that the Government be asked to take over the administration and distribution of direct relief in Burnaby from and after that date. Carried unanimously.
