

Tuesday - October 11th, 1932.

An adjourned meeting of the Council was held at the Municipal Hall on Tuesday October 11th, 1932 at 7.30 p.m.

Present: His Worship the Reeve in the chair.
Councillors Martin, Brown, Lambert, Lench, Wheatley, Gray and Hatherly.

Correspondence was received and dealt with as follows:

Workers Ex-Servicemen's League - North Burnaby Branch - advising that complaints had been received at their meeting re alleged profiteering by merchants filling Relief script, and advising that unless steps are taken to stop same list of names of the firms concerned will be published.

Moved by Cr.Wheatley, Seconded by Cr.Brown: "That the letter be received and filed."

Carried unanimously.

James Shaw - complaining of building being erected on lot adjacent to his home which he alleged is being built in contravention of the Building By-law. The Building Inspector submitted report and sketch showing location of the building in question and advised that the building was being built in accordance with the Building By-law.

Moved by Cr.Brown, Seconded by Cr.Lench: "That the report of the Building Inspector be adopted and that the letter from Mr. Shaw be received."

Carried unanimously.

His Worship Reeve Pritchard - submitted report advising that cheques totalling \$17,839.45 and \$993.21 had been received from the Provincial Government covering Direct relief vouchers up to September 17th, 1932 and Municipal and Provincial share of unemployment relief pay roll up to September 30th respectively

Moved by Cr.Wheatley, Seconded by Cr.Hatherly: "That the report be received."

Carried unanimously.

The Relief Officer submitted report for week of September 26th to October 1st. showing total number of cases as 1371 with total expenditure of \$8,714.52

Moved by Cr.Wheatley, Seconded by Cr.Lambert: "That the report be received."

Negatived - Crs. Hatherly, Wheatley and Lambert and Reeve Pritchard voting in favour - Councillors Martin, Brown, Lench and Gray voting against:

The Relief Officer submitted report showing number of investigations carried out for week October 3rd to October 8th. amounting to 251.

Moved by Cr.Wheatley, Seconded by Cr.Hatherly: "That the report be received."

Carried unanimously.

The Relief officer submitted report showing number of stores still carrying on in matter of filling relief orders, together with statement showing details of partial orders being given out by his Department.

Moved by Cr.Hatherly, Seconded by Cr.Wheatley: "That the reports be received."

Carried unanimously.

2. The Relief Officer submitted report on matter of payment of rents advising that a total of 469 families, now on relief were residing in rented homes and that in 209 cases the rent was being paid by the Corporation.

Moved by Cr.Hatherly, Seconded by Cr.Martin: "That the report be received and be referred to the Standing Relief Committee for consideration and recommendation."

Carried unanimously.

The Treasurer submitted an application from H.R. Wratzlaw to purchase Tax sale certificate covering North half of Lot "D" SD "A" Blk.4. D.L. 42.

Moved by Cr.Martin, Seconded by Cr.Lambert: "That this application be referred to the Standing Property committee for recommendation."

Carried unanimously.

His Worship the Reeve tabled report as President of the Union of B.C. Municipalities of the recent conference at Victoria in October.

Moved by Cr.Wheatley, Seconded by Cr.Hatherly: "That the report be received."

Carried unanimously.

Moved by Cr.Gray, Seconded by Cr.Martin: "That the local Federal member Mr. Tom Reid, M.P. be written to requesting him to use his good offices while at Ottawa to forward the application of this Corporation for a loan under the provisions of the Federal Bill No.72."

Carried unanimously.

The Council then adjourned.
