Moved by Cr.Lambert, Seconded by Cr.Lench: "That the Local member Mr. W.R.Rutledge be requested to advise what he knows in relation to the application of this Corporation for a loan of 135,000.00 to finance Direct relief costs for the year 1932. Carried unanimously.

The Relief Officer submitted report showing number of investigations carried out by relief department week of May 16th to May 21st amounting to 287 - Total to May 21st. 4575.
Moved by Cr. Wheatley, Seconded by Cr. Hatherly: "That the report be received." Carried - Cr.Martin against.

The Relief officer submitted request that matter of payment of rents be taken up immediately as the situation was now at a point where a definite policy in this regard must be adopted. Moved by Cr. Wheatley, Seconded by Cr. Kambert: "That the report be received Carried unanimously."

Moved by Cr. Wheatley, Seconded by Cr. Lambert: "That the Council as a committee of the whole meet with Mr. Scharnschmidt, of the Provincial Government, and discuss this matter at the earliest possible date." Carried unanimously.

The Relief officer submitted list of stores where filling of relief orders had been stopped, and that as a result a certain amount of confusion and disorganization had result occurred.
Moved by Cr. Lambert, Seconded by Cr. Wheatley: "That the report be received."

Carried unanimously.

Moved by Cr. Lambert, Seconded by Cr. Lench: "That the matter of providing work in return for relief be taken up with Mr. Scharnsminidt at the meeting to be arranged for this week."
