Firstly: the time for concluding all works presently under way and not capable of being finished before the first of May may on application be extended to permit of such

works being finished provided that such works are of such a character that the stopping of same would cause loss by reason of their non-completion; for example, in the case of buildings, sewers, and works of like character.

Secondly: where contractual undischarged obligations under entire contracts exist, the time for completing such works in order to fulfil suchcontracts and discharge such obligation may be extended.
