Moved by Cr.Wheatley, Seconded by Cr.Lench: "That the committee do now rise and report the by-law complete without amendment."

Carried - Cr.Martin against.

Moved by Cr.Wheatley, Seconded by Cr.Lench: "That the Burnaby Waterworks Fegul-

ation By-law No.2.1936 Amendment By-law 1932 be now read a third time."

Carried - Cr. Martin against.

Moved by Cr. Wheatley, Seconded by Cr. Lench: "That the Burnaby Waterworks Regulation By-law No. 2. 1926 Amendment By-law 1932 do pass the Third reading, that it be signed by the Reeve and Clerk and that the corporate seal be affixed thereto." Carried - Cr.Martin against.

The Chief Constable submitted report on application of Mrs.J.F.Murray for a Barbecue license for premises at corner of Douglas Road and Sperling Avenue, - advising that as far as the personal character of the applicant was concerned he believed she was a fit and proper person to be licensed, but recommended that owing to the night life attracted by such businesses and the consequent increase in Police supervision necessary that the application be not entertained.

Moved by Cr. Lench, Seconded by Cr. Hatherly: "That the recommendation of the Chief Constable be adopted." Carried unanimously.

John Freeman wrote with reference to his new lot boundary lines advising that the re-survey and re-contouring of Capitol Hill had moved his lot boundaries 1 foot to North and West and he was unwilling to meet any further expense in matter of reconstructing his fence. Moved by Cr.Martin, Seconded by Cr.Hatherly: "That this matter be referred to the Engineer for report."

Carried unanimously.

T.Farrington wrote advising that the BurnabyExservicemen's Unemployed Association had been formed and requesting bearing for representatives. Mr.Farrington attended and addressed the Council on the aims and objects of the newly formed association and requesting that said organization receive the co-operation of the Council whenever possible.

Moved by Cr.Martin, Seconded by Cr.Lench: "That the letter be received and filed." Carried unanimously.

His Worship the Reeve submitted resume of correspondence between Corporationof Burnby and the various Provincial and Dominion Government departments re unemployment relief metters for period between February 22nd. to February 29th.

Moved by Cr. Wheatley, Seconded by Cr. Hatherly: "That the report be received." Carried unanimously.

Cr. Wheatley advised that a mass parade of Burnaby Unemployed had been arranged for 12.30 p.m. Thursday at the Municipal Hall, Edmonds, and invited as many of the Council to be present as can do so. Moved by Cr. Wheatley, Seconded by Cr. Hatherly: That as many of the Council as can do so attend."
