Moved by Cr.Martin, Seconded by Cr.Lambert: "That item - Municipal Government - Audit fees - \$800.00 - pass."

Carried unanimously.

Moved by Cr.Martin, Seconded by Cr.Lambert: "That Council indemnifies except Reeve's indemnify be reduced by 10%" His Worship the Reeve vacated the chair. The Acting Reeve - Cr.Lambert declined to take the chair. Moved by Cr.Martin, Seconded by Cr.Lambert: "That Cr.Gray do take the chair."

Moved by Cr.Martin, Seconded by Cr.Lench: "That salary of Engineer Mr.Davidson be reduced to 3,600.00; that salaries of Mr.Southwell, Mr.Hawkins, and Mr. Scott be reduced by 10%; that salary of Mr.Etches be reduced by 7%, and Messrs 2 Devidson and Scott alternate, and that Messrs Hawkins and Southwell alternate until conditions otherwise warrant."

Carried - Crs. Hatherly and Reeve Pritchard voting against.

Moved by Cr.Martin, Seconded by Cr.Lambert: "That following reductions in salaries Clerks Department and General office be made, 1.e. Salaries of from \$1000, to \$1500.00 5% 1500. to 2000.00 7

and that no change be made in salaries under \$1000.00, and that this be basis for all other departments, except the Engineering Department, over which the Council has jurisdiction.

Carried - Reeve Pritchard and Cr.Hatherly against.

The Committee then adjourned.
