Department of Public Works - acknowledging receipt of communication re Bulkheads on Kingsway and advising that he will look personally into the matter on the ground when next on the mainland, but that the department could admit no responsibility for the maintenance of these bulkheads.

Moved by Cr.Gray, Seconded by Cr.Wheatley: "That the letter be received and a delegation be named to Meet the Chief Engineer when on the ground."

Carried unanimously.

Crs. Wheatley, Gray and Martin with the Engineer were named the committee.

Minister of Finence - acknowledging receipt of application from this Council for a loan of \$135,000.00 to finance Direct relief ro 1932 and advising that in the absence of further information from the Bederal Government no decision could be made at this time, but that we would be communicated with firther in due course.

Moved by Cr. Lambert, Seconded by Cr. Martin: That the letter be received and filed.

Carried unanimously.

The Relief officer submitted weekly report showing total relief issued for week of April 25th to April 30th. amounting to \$12,670.69

Moved by Cr.Hatherly, Seconded by Cr.Wheatley: "That the report be received."

Carried - Cr.Martin against.

Moved by Cr.Lench, Seconded by Cr.Gray: "That the Relief officer be asked to bring down report as to how many families are receiving relief who have become residents of this Municipality within the past six months with a statement as to the length of residence before they first received relief."

Carried unanimously.

The Relief officer submitted report showing number of investigations made in respect of direct relief for the week of May 2nd to 7th. as 263.

Moved by Cr. Wheatley, Seconded by Cr. Hatherly: "That the report be received."

Carried - Cr. Martin against.

Moved by Cr. Lench, Seconded by Cr. Brown: "That the relief officer be requested to bring down report showing number of investigations made to date in respect of direct relief."

Carried - Cr. Wheatley against.

The special committee on claims for compensation - Sheep Protection Act submitted report advising that in the opinion of the committee sufficient proof had not been submitted to satisfy the Committee that the damage had been occasioned by dogs and further that no evidence had been adduced that the birds had been properly housed and otherwise protected. The committeer commended that the claims be not entertained.

Moved by Cr. Wheatley, Seconded by Cr. Brown: "That the re Commendation be adopted."

An amendment was Moved by Cr.Gray, Seconded by Cr.Martin: "That the report be received and be referred back forfurther explanation of the last clause."

The amendment was Lost - Crs. Wheatley, Brown, Lench, Hatherly and Martin voting against.

The motion was then put and carried - Cr.Gray voting against.

The Deputy Engineer submitted a report advising that the Vancouver Rowing Club have lived up to the terms of the lease in so far as the Engineering side of the matter was concerned.

Moved by Cr. Wheatley, Seconded by Cr. Lambert: "That the report be received." Carried unanimously.

His Worship the Reeve submitted resume of correspondence re Unemployment relief for period since May 2nd. 1932.
Moved by Cr. Wheatley, Seconded by Cr. Hatherly: "That the report be received." Carried unanimously.

E.P.Brennan submitted application for approval of scheme to construct and operate a Memorial Park for interment purposes in D. L.81.

Moved by Cr.Lambert, Seconded by Cr.Wheatley: "That this application be referred to the Property Committee for recommendation."
Carriedunanimously.

Moved by Cr. Wheatley, Seconded by Cr. Martin: "That this Council do now adjourn." Carried unanimously.
