

Wednesday - June 7th, 1933.

A Regular sitting of the Commissioner was held at the Municipal Hall on Wednesday June 7th, 1933 at 10.00 a.m.
Present: Commissioner John Bennett - and Municipal Clerk.

Ordered: "That the minutes of the sitting of May 31st ultimo be adopted as written and confirmed."

Correspondence was received and dealt with as follows:

1. Central Park Local Committee - requesting information as to disposition of their request for permission to establish and operate a tent tourist camp in Central Park.
Ordered: "That the letter be received and filed and that the Central Park Local Committee be advised that owing to adverse reports from the Town Planning Committee, the South Burnaby Board of Trade and the S.W. Burnaby Ratepayers Association the Commissioner cannot see his way to granting their request at this time."

2. Catholic Children's Aid Society - forwarding Committal order re Marie McNeil, together with order against the Corporation in sum of \$4.00 per week until child reaches the age of 18 years.
Ordered: "That the orders be received and filed."

3. The Deputy Municipal Engineer submitted a recommendation that portion of Cariboo Park be cleared and graded for a soft ball field chargeable against the funds accumulated from rent of building situate on the Park.
Ordered: "That this report be tabled and the engineer be requested to report further as to best method of developing this Park."

4. The Deputy Municipal Engineer submitted report on application of C.H. Whellams to have Keith Street opened up to West part of Lot 2, SD "A" D.L. 162 and recommended that as Mr. Whellams can obtain access to his property off Marine Drive that the application be not entertained.
Ordered: "That the report and recommendation of the Engineer be approved."

The Relief Officer submitted report (tentative) for month of May 1933 showing total number of cases as 2238 with total expenditure of \$41,755.59 a decrease of \$3,074.63 over the month of April.
Ordered: "That the report be received and filed."

The Treasurer submitted recommendation that Tax sale certificates be sold as follows

5/6 Lots 10 and 11, Block 23, D.L. 159 to W.O'D. Telford Estate \$204.54
Lot 47, Block 35, D.L. 188 to Matthew Christer 53.00

Ordered: "That the recommendation of the Treasurer be and is hereby adopted."

Ordered: "That the District of Burnaby Greater Vancouver Water Districts Accounts Payment Extension By-law 1933 be introduced and read a first time."

Ordered: "That the District of Burnaby Greater Vancouver Water Districts Accounts Payment Extension By-law 1933 do pass the first reading."

Ordered: "That the District of Burnaby Greater Vancouver Water Districts Accounts Payment Extension By-law 1933 be now read a second time."

Ordered: "That the District of Burnaby Greater Vancouver Water Districts Accounts Payment Extension By-law 1933 do pass the second reading."

Ordered: "That accounts as follows be approved for payment as and when funds are available:
