E.G. Howell and T.H. Moul - applying to purchase wood off Lot 4, Block 28, D.L.189. for commercial purposes.

C.Knapton & D.Lynda - requesting an extension of 50 cords on their permit to cut wood off Block 7. D.L. 171. for commercial purposes.

The Deputy Municipal Engineer submitted report on offer of Mr. Thomas Storey to give a free conveyance of East thirty three feet of Lot "A" Block 15, D. U. 93. for purpose of providing additional road allowance for Russell Avenue, and recommended that the offer be accepted.

The Requisitions were then examined.
Ordered: "That the Requisitions as submitted be approved."

Ordered: "That General accounts \$8,224.77; Relief Accounts \$28,759.95; Pay Rolls \$1,816.81; Mileage accounts \$34.35; Land Sale commissions \$4.75 and February salaries \$5,565.71 be approved for payment as and when funds are available."

J.E.Lekala and others wrote with reference to proposal to carry out improvements to Byrne Road by volunteer labor and requested that the road be improved forthwith Mr.Peter Warren and othersaddressedthe Commissioner on this matter.

Ordered: "That the letter be received and be tabled for consideration."
