

Thursday - May 10th. - 1934.

A sitting of the Commissioner was held at the Municipal Hall on Thursday, May 10th. 1934 at 10.00 a.m.

Present: Commissioner H.M. Fraser; Treasurer R. Bolton; and the Municipal Clerk.

Ordered: "That the minutes of the sitting of May 2nd inst. be adopted as written and confirmed."

The Treasurer submitted recommendation that Tax sale certificate covering East $\frac{1}{2}$ Lot 12, Block 34, D.L. 151/3 be sold to Mr. William David Bowden of 713 Columbia St. New Westminster for the sum of \$177.59

Ordered: "That the recommendation of the Treasurer be and is hereby adopted."
