Linkingon King - Department of Public Works wrote re Central Arterial Highway 17R advising that until such time as the Highway is completed the question of repairing the present road is purely one for the Municipality to undertake. Ordered: "That this communication be referred to the Clerk, Engineer and Solicitor to reply.

Union of B. C. Municipalities wrote requesting that the sum of \$2.00 per capita on all present contributors to the fund; of this sum \$1.00 to be paid by the employer and \$1.00 by the employee to defray expenses for acturial services in connection with the question of Civic Superannuation.
