Ordered: "That the Commissioner and Clerk be and are hereby authorized to execute Agreement between William Copping and the Corporation of the District of Burnaby respecting private crossing to N.E. corner of E. Part of S $\frac{1}{2}$ of District Lot 8, and to affix the Corporate seal thereto."

Requisitions were then examined.

Ordered: "That requisitions as submitted be approved."

Ordered: "That the Commissioner do now sit as a Committee of the whole to re-consider Burnaby Land Sale By-law No. 8, 1936."

Ordered: "That the Committee do now rise and report the By-law complete without amendment."

Ordered: "That Burnaby Land Sale By-law No. 8, 1936 be now read a third time."

Ordered: "That Burnaby Land Sale By-law No. 8, 1936 do pass the third reading, that it be signed by the Commissioner and the Clerk and that the Corporate seal be affixed thereto."

The meeting then adjourned.
