Ordered: "That the Committee do now rise and report the By-law complete without amendment."

Ordered: "That Burnaby Delinquent Taxes By-law 1937 be now read a third time."

Ordered: "That Burnaby Delinquent Taxes By-law 1937 do pass the third reading, that it be signed by the Commissioner and Clerk, and the corporate seal be affixed thereto."

Ordered: "That the orders made on June 30th and July 7th respectively respecting Saunders Tax Adjustment By-law 1937 be and are hereby rescinded."

Ordered: "That the Saunders Tax Adjustment By-law 1937 be introduced and read a first time."

Ordered: "That the Saunders Tax Adjustment By-law 1937 do pass the first reading."

Ordered: "That the Saunders Tax Adjustment By-law 1937 be now read a second time."

Ordered: "That the Saunders Tax Adjustment By-law 1937 do pass the second reading."
