Ordered: "That Burnaby Electrical Inspection By-law 1928 Amendment By-law 1938 be introduced and read a first time."

Ordered: "That Burnaby Electrical Inspection By-law 1928 Amendment By-law 1938 do pass the first reading."

Ordered: "That Burnaby Electrical Inspection By-law 1928 Amendment By-law 1938 be now read a second time."

Ordered: "That Burnaby Electrical Inspection By-law 1928 Amendment By-law 1938 do pass the second reading."
