

Wednesday - October 8th, 1941

A regular sitting of the Commissioner was held at the Municipal Hall on Wednesday, October 8th at 10:00 a.m.

K. J. Burns, Port Manager for Vancouver Harbour wrote re report from Dr. William Sager dated June 18th, 1940 in connection with conditions of 184 shacks and dwellings located on the waterfront between Boundary Road and Port Moody requesting information as to any changes at this time.

Ordered: "That the matter be referred to the Medical Health Officer for immediate report."

Senior Medical Health Officer wrote re Rockefeller Foundation granting the continuation of the Burnaby grant for a further 19 months which will complete the five year period by October 31st, 1943.
