Block 9. D.L. 121 be approved as a suitable site for a Community Hall and that if possible the area should be extended by the inclusion of such other lots adjacent thereto as may be available.

Dr. A. W. Black, Unit Director, wrote advising the Council of the establishment of the Burnaby Sub-committee on Emergent Epidemics the primary aim of the Committee being the organization of community resources in preparation for any emergent epidemic which may follow in the wake of World War 11.

Moved by Cr. Philps, Seconded by Cr. West: "That the letter be received and Item No. 2 be referred to Committee on Licenses."

Carried unanimously.

Moved by Cr. Ball. Seconded by Cr. West: 'That Item No. 1 be laid over pending report as to costs and that a Committee be set up to obtain such information.'

Carried unanimously.

A Committee consisting of Crs. Gartlan, West, Wilson and Reeve Morrison was set up.

W. B. Western and R. M. Western wrote submitting application for a waiver of the Town Planning By-law to permit the erection and operation of a Hardware Store on Lot 20, Blocks 28,29, D.L. 98 situated at the north-east corner of Royal Oak Avenue and Rumble Street Moved by Cr. West, Seconded by Cr. Philps: "That the letter be received and filed and the By-law be waived as applied for."

Carried unanimously.

Mrs. M. J. Bishop wrote with reference to property at 3736 Hastings Street which was owned by herself and which had been rented to Mr. Wood who has now transferred his business to an Oriental, Chinese. Mrs. Bishop requests the Corporation not to approve of the transfer of this license as she does not wish an Oriental to coupy her premises.

Moved by Cr. West, Seconded by Cr. Ball: "That the letter be received and filed and the applicant be informed that the Corporation have no grounds on which to refuse a license to an Oriental and that the matter is entirely in her own hands as the owner of the property concerned."

Carried unanimously.

The Clerk advised that Mr. C. M. Flack of Flack Investments Limited was in attendance and wished to speak to the Council in connection with a proposed industry.

Mr. Flack addressed the Council advising that his clients, Kelly Douglas, were considering the purchase of the Shewan property and Coulter property for the purpose of establishing a food factory and that as this property was partially within a Commercial area and partially in an Industrial area with a portion in between being in a Residential area, he hequested the favourable consideration of the Council in the matter of waiving the By-law to permit the establishment of such an Industry.
