THEREFORE the City Council of the City of Vancouver be requested to amend the City of Vancouver Taxi By-law to permit bona fide taxi operators carrying on business at Boundary Road and Hastings Street to operate within the City of Vancouver at the intersection of Kootenay Street and Hastings Street East. Carried Unanimously

Moved by Cr. Drummond, Seconded by Cr. Isherwood: "That WHEREAS the provisions of paragraph 18 of Section 58 of the Municipal Act gives power to a Municipal Council to operate municipal buses without the Municipality subject to the Municipality entering into an agreement with a Neighbouring Municipality: AND WHEREAS with the terminus of the Street Car service from the City of

Vancouver being at the Burnaby Municiral boundary at Boundary Road and Hastings Street the Municipality of Burnaby could operate Municipal buses entirely within the limits of the Municipality of Burnaby without having to extend same within the limits of any other Municipality. AND WHEREAS with the removal of the street car terminus from Boundary Road and Hastings Street to Kootenay Street and Hastings Street, this condition will

no longer exist

THEREFORE the Municipal Council of the Corporation of the District of Burnaby request that the City of Vancouver give assurances to the Municipality of Burnaby that in the event of the Corporation of the District of Burnaby operating a Municipal Bus Service from any point in the Municipality of Burnaby to the intersection of Boundary Road and Hastings Street East, the City will be prepared to enter into an agreement with the Corporation of the District of Burnaby to : permit such buses to operate within the City of Vancouver on Hastings Street to the intersection of the said Hastings Street and Kootenay Street. Carried Unanimously

Secretary, Town Planning Commission wrote with reference to property described Block "A", J.L. 68 advising this property had been reserved some years ago for park purposes, the south half of which had recently been set aside as a site for the proposed Burnaby Rospital leaving the north half still reserved as a park site, recommending that the west half of this remaining portion be related for sale, as it was considered unsuitable for park purposes. Moved by Cr. Armstrong, Seconded by Cr. Philps: "That the recommendation of the Town Planning Commission be adopted."
