Moved by Cr. Isherwood, Seconded by Cr. MacSorley: "That the communication be received."

Inspector of Municipalities wrote advising that, approval pursuant to Section 186(2) of the "Municipal Act" was given to "Burnaby Waterworks Loan By-Law 1950", providing for the borrowing of a sum of \$892,000.00 by way of 20 year 4% serial debentures finally maturing in 1971 for the purpose of extending, renewing and improving the waterworks system in the Municipality, Moved by Cr. Isherwood, Seconded by Cr. MacSorley: "That the communication be received."

Wilks: "That the vote of the electors on Burnaby Waterworks Loan By-law 1950 be taken at the same time as the General Election on December 16th 1950, that Charles B. Brown be appointed Returning Officer for the purpose of taking the vote, and that polling places be the same as those selected for the General Election."

MacSorley: "That (1) enter rates be increased \$5.00 per year in respect of the flat rates (2) discount on meter rates be reduced to 10%, (3) minimum meter rate be increased to \$1.75 per month, plus meter rent, that the discount on flat rates be \$2.00 per year if paid semi-annually, and \$3.00 per year if paid on or before the first discount date, and and that the By-law be ammaded to provide that the first discount date for the year 1951, be February 28th 1951, "further that the Clerk be instructed to take the necessary steps to effect these changes."
