General Manager of Transportation, B. C. Electric Railway Company Limited, wrote with reference to the construction of a bus loop at Edmonds Street and Kingsway, advising that while in conference with the Transportation

Committee of the Council it had been decided the construction of suitable loop facilities for buses at this point should be left in abeyance pending finalization of the all bus plan for the entire Municipality. Moved by Councillor Armstrong and seconded by Councillor Charlton "That the communication be received."

Mrs. E. Ross wrote protesting the suggested change in the Capitol Hill bus routing along Ellesmere Avenue from Hastings Street. Moved by Councillor Isherwood and seconded by Councillor Charlton "That the communication be received and referred to the Transportation Committee."

Carried Unanimously.

Burnaby Lions Club wrote requesting permission to hold their Annual Carnation Tag Day on Saturday, May 11, 1952. Moved by Councillor Sargent and seconded by Councillor Charlton "That permission be granted as requested."
