Carried Unanimously.

Chief Building Inspector submitted report on the application by J. C. Becher for permission to convert premises at 2607 Melson Avenue into a six suite apartment building, recommending approval of this application. Moved by Councillor Philps and seconded by Councillor Jrummond "That the recommendation of the Building Inspector be adopted.

Carried Unanimously.

Town Planning Commission submitted report recommending the following: That Block 14, J.L. 44 be resoned from Small Holding to Light Industrial. This property is located on Bainbridge Avenue and Government Road and application for the rezoning was submitted by the Jominion Construction Company, who desired to develop this land as an assembly site for the Austin Motor Company. The Commission received a number of complaints from residents living on Bainbridge Avenue, Phillips Avenue and Government Road protesting against the proposed rezoning. In the opinion of the Commission the complainants would not be effected by the proposed resoning, particularly

those on Bainbridge Avenue and Phillips Avenue.

That the application of the Home Oil distributors Ltd. for the rescning of portion of Lot "A", Block 1, J.L. 175, Nd. having a frontage of 100" on Boundary Road and 121,14" on Rumble Street, from Residential to Gasoline Service Station zone be approved.

Moved by Councillor Armstrong and seconded by Councillor Isherwood "That the mesonmentations of the Town Planning Countered Paradon be released." the recommendations of the Town Planning Commission be adopted.

Carried UnanimousLy.

Administration Committee submitted report on the request received from the Burnaby General Hospital for a refund of the sum of \$2,190.21, paid by their Hospital Board as tax assessment for the year 1953 and stated the matter had been thoroughly investigated and they were of the opinion that the Corporation is justified in making the charges, recommending that no refund be made. Moved by Councillor Philps and seconded by Councillor Wilks "That the recommendation of the Committee be adopted."

Carried Unanimously.

Moved by Councillor Philps and seconded by Councillor Drummond "That the Reeve and Clerk be granted authority to execute an agreement with the Civic Employees Union embodying all recent alterations agreed upon between the Council and the Union, and that the Corporate Seal be affixed thereto."

Carried Unanimously.

Councillor Isherwood withdrew.

Moved by Councillor Jrummond and seconded by Councillor Charlton "That Burnaby Land Sale By-14w No. 22, 1953" be now reconsidered." Carried Unanimously.

Moved by Councillor Jrummond and seconded by Councillor Charlton "That "Burnaby Land Sale By-law No. 22, 1953" be now finally adopted, that it be signed by the Reeve and Clerk and that the Corporate Seal be affixed thereto."

Carried Unanimously.

Councillor Isherwood returned. Moved by Councillor MacSorley and seconded by Councillor Philps "That the Council do resolve into a Committee of the Whole with the Reeve in the Chair to consider "Burnaby Waterworks Loan By-law 1953".

Carried Unanimously.

The Reeve asked the question: "What is your pleasure with this By-law?"

Moved by Councillor MacSorley and seconded by Councillor Drummond "That the By-law be read by short title only.

Carried Unanimously.

Moved by Councillor MacSorley and seconded by Councillor Armstrong That the Committee do now rise and report the By-law complete without amendment.

The Council re-convened.

Moved by Councillor MacSorley and seconded by Councillor Wilks "That "Burnaby Waterworks Loan By-law 1953" be now passed."

Carried Unanimously.

Moved by Councillor MacSorley and seconded by Councillor Armstrong "That a committee be set up to prepare suitable advertising to publicize the "Burnaby Waterworks Loan By-law 1953" and that sufficient funds be authorized to cover such publicity."

Carried Unanimously.

Moved by Councillor Isherwood and seconded by Councillor Philps "That Carles B. Brown be and is hereby appointed Returning Officer with power to appoint his own Deputy Returning Officers, for the purpose of taking votes of the electors at the By-law Election on Thursday, Friday and Saturday, December 10th, 11th and 12th, 1953 on the "Burnaby Waterworks Loan By-law 1953".
