A regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, December 1, 1958 at 7:30 p.m.

Reverend David Forbes led in Opening Prayer.

Moved by Councillor Cafferky, Seconded by Councillor Wilson: "That the minutes of the previous meeting be adopted as written and confirmed."

CARRIED UNANIMOUSLY

Moved by Councillor Cafferky, Seconded by Councillor Brown: "That Councillor Seifner be granted leave of absence."

CARRIED UNANIMOUSLY!

J. A. Muri wrote requesting to be heard in the matter of the rezoning from "Two Family Dwelling" to "Multiple Family Dwelling" of Lot "B", Block 68, D. L. 189, Plan 13565.

Moved by Councillor Wilson, Seconded by Councillor McLean: "That Mr. Muri be heard on this matter."

CARRIED UNANIMOUSLY

Mr. Muri was not in attendance at the meeting.

Moved by Councillor Wilson, Seconded by Councillor Cafferky: "That Mr. Brine be heard on this matter."

Mr. Brine requested that the petition submitted be read.

The petition is as follows:

"We, the undersigned property owners, have recently learned that the Municipality has under consideration the development of a major North-South arterial road, on the South side of Deer Lake.

We, as taxpayers, feel that the proposed roadway would depreciate the value of the land and in large measures sacrifice the natural amenities of the Deer Lake area. It would make impossible the type of residential development we, the residents, envision for this area.

We request that you consider this petition and allow us an opportunity to express our views before the plans are finalized."

The petition is signed by Mr. Ralph H. Brine and others.

Mr. Brine addressed the Council requesting an opportunity to discuss this matter at length with the Municipal Council.

Moved by Councillor Mather, Seconded by Councillor Brown: "That this matter be referred to the meeting of the Municipal Council to be held December 2, 1958."

W. D. Black, Provincial Secretary, in response to our request for information as to the number of vacant beds at the Woodlands School due to the shortage of competent staff. It was noted that this is a gradual changing figure and the figures quoted for today would not necessarily be true for tomorrow. It is expected that Ward 14, Fraserview Wing, will be opened early in December. This Ward will accommodate 73 cribs and require a staff of 40 persons.

Moved by Councillor Mather, Seconded by Councillor McLean: "That this correspondence be received."

TRAFFIC AND TRAFFIC SAFETY COMMITTEE

The Traffic and Traffic Safety Committee reported on the undermentioned matters which were dealt with as follows:

(1) All day parking on 6th Street between 13th Avenue and 14th Avenue.

Recommending that:

- (a) Further spot checks be made of parking in this vicinity.
- (b) That the applicant be advised if further difficulty is encountered he may apply for and have installed a property sidewalk crossing adjacent to his loading doors and that this crossing would be covered by a parking prohibition which will be enforced in the normal manner.

Moved by Councillor Cafferky, Seconded by Councillor Jamieson: "That the report of the Committee be adopted."

CARRIED UNANIMOUSLY

(2) Keswick - Lougheed to Cameron.

Advising of the problem created when an increase of traffic is experienced on a residential road. It was recommended that the request for a 15 m.p.h. speed restriction be not entertained, for it was felt that the imposition of such a restriction would not necessarily solve this problem but would only transfer the problem to another Municipal street.

Moved by Councillor Mather, Seconded by Councillor Jamieson: "That the report of the Committee be adopted."

CARRIED UNANIMOUSLY

(3) Sussex - Kingsway to Kelly-Douglas Warehouse.

Recommending that no further action be taken on the request for the creation of two hour parking zones on this street. It was found that parking on both sides of Sussex was orderly and the street width is adequate for passage of Commercial vehicles in both directions.

Moved by Councillor Brown, Seconded by Councillor Jamieson: "That the report of the Committee be adopted."

CARRIED UNANIMOUSLY

(4) Willingdon and Kingsway - Improper Turning Movements.

Advising of a problem created when motorists drive over the sidewalk and curb allowance at the right side of the stop sign at this intersection. It was recommended that a black and white striped and reflectorized barrier be installed in such a manner as to prevent this undesirable traffic movement.

Moved by Councillor Jamieson, Seconded by Councillor Brown: "That the report of the Committee be adopted."

CARRIED UNANIMOUSLY

(5) Bus Zones on Hastings Street.

Advising of a comprehensive study that had been made of the bus stops and bus zones on Hastings Street between Willingdon and Gilmore.

The following recommendations were put forward:

- (1) That the existing bus stop on the North side of Hastings Street west on Willingdon Avenue be made a bus zone, such zone to extend from 105 feet west to 170 feet west of the west street line of Willingdon Avenue.
- (2) That the existing bus stop on the north side of Hastings Street west of Rosser Avenue be made a bus zone, such zone to extend from 20 feet west to 60 feet west of the west street line of Rosser Avenue.
- (3) That the existing bus stop on the north side of Hastings Street east of Madison be relocated to a farside position and be made a bus zone, such zone to extend from /2 feet west to 137 feet west of the west street line of Madison Avenue.
- (4) That the existing bus stop on the north side of Hastings Street west of Carleton Avenue be made a bus zone, such zone to extend from 20 feet west to 60 feet west of the west street line of Carleton Avenue.
- (5) That the existing bus stop on the south side of Hastings Street east of Carleton Avenue be made a bus zone, such zone to extend from 20 feet east to 85 feet east of the east street line of Carleton Avenue.
- (6) That the existing bus stop on the south side of Hastings Street west of Madison Avenue be relocated to a farside position and be made a bus zone, such zone to extend from 36 feet east to 71 feet east of the east street line of Madison Avenue.
- (7) That the existing bus stop on the South side of Hastings Street east of Rosser Avenue be made a bus zone, such zone to extend from 49 feet east to 114 feet east of the east street line of Rosser Avenue.
- (8) That the signs used to define the zones bear the words: "No Stopping Bus Zone."

Moved by Councillor McLean, Seconded by Councillor Jamieson: "That the report of the Committee be adopted."

(6) Rush Hour Parking on Hastings Street between Gilmore Avenue and Boundary Road.

Recommending that a parking prohibition between the hours of 4:00 p.m. and 6:00 p.m. be created for the south side of Hastings Street between Gilmore Avenue and Esmond Avenue and that adequate signing be installed.

12. Re: Flooding and Drainage Problems raised by Brentwood Park Ratepayers Association.

Reporting the investigations conducted in response to a letter received by Council $17\,\mathrm{th}$ November, 1958. Two items were noted in the letter, the items are:

- (a) The matter of deep drainage ditches surrounding the park and school area;
- (b) Matter of flooding of premises on Westlawn Drive.

In regards Item (a) it was found that the drainage ditches around school and park areas are not accessibly deep, nevertheless the Manager has been advised that some work will be done to improve the condition; (b) The problem created on 22nd September, 1958 as a result of a localized flash flood was thoroughly investigated. The Engineer suggests that the most likely insurance against a recurrence of this particular problem would be by separating the roof drainage from the foundation drainage with the installation of sumps,

back water valves and possibly pumps to some of the low lying houses.

Moved by Councillor Jamieson, Seconded by Councillor Cafferky: "That the recommendations of the Manager be adopted."
