It is also hoped that Department Heads of the Provincial and Federal Governments may be able to attend. It is further suggested that Mr. John Prior chair this meeting.

Moved by Councillor Cafferky, Seconded by Councillor Jamieson: "That this Corporation pursue deligently through the Members of the Legislative Assembly and by all other means at its disposal the establishment of a temporary Motor Vehicle License office within Burnaby and that space be made available by the Corporation of Burnaby for this purpose."

Moved by Councillor Cafferky, Seconded by Councillor Mather: "That the funds required to meet the Parks over expenditure \$3,500.00 be transferred from the contingency appropriation."
