A Regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, March 2, 1959 at 7:30 p.m.

PRESENT:

Reverend I. Cumming led in Opening Prayer.

Moved by Councillor McLean, Seconded by Councillor Edwards: "That Councillor Brown be granted leave of absence."

CARRIED UNANIMOUSLY

Moved by Councillor Jamieson, Seconded by Councillor Mather: "That the Minutes of the previous meeting be adopted as corrected."

CARRIED UNANIMOUSLY

Mr. H. E. Martin requested an opportunity to address the Council.

Moved by Councillor MacSorley, Seconded by Councillor Seifner: "That the delegation be heard."

CARRIED UNANIMOUSLY

Mr. Martin was in attendance and addressed the Council expressing his concern over the proposed sewer financing scheme, particularly as it would affect property owners on McKay Avenue.

TRAFFIC SAFETY COMMITTEE -- REPORT NO. 3, 1959.

(1) Pedestrian Crossing - Kingsway and McMurray.

Your Committee recommends that the Municipal Council request that the Department of Highways conduct a pedestrian count at this location, which information would be necessary to justify the installation of a pedestrian actuated traffic control light.

Moved by Councillor Seifner, Seconded by Councillor MacSorley: "That this recommendation be adopted."

CARRIED UNANIMOUSLY

(2) Imperial Street and Jubilee Avenue.

Upon the request of Council a supplementary study has been made of the above intersection. The study included a Friday evening count from 5:00 p.m. to 9:30 p.m. on February 13, 1959 with additional observation on Saturday, February 14, 1959 from 10:00 a.m. to 11:00 a.m. and from 2:45 to 3:45 p.m. Results of this study is as follows:

- (a) Friday evening peak occurs at the normal time, that is between 4:30 p.m. and 5:30 p.m. and is about 11% higher than the count taken for the same times on a Thursday.
- (b) During the early hours of the count the Traffic was found to be moderate. Traffic volumes decreased steadily from the peak hour.
- (c) That considerable indiscriminate use of the intersection by pedestrians adds to the general confusion occasioned by the unusual shape of the intersection.

Your Committee would reaffirm the recommendations contained in Report No. 2, 1959 submitted to Council February 5, 1959.

Moved by Councillor Jamieson, Seconded by Councillor Prittie: "That Council concurs with the recommendations contained in Report No. 2, 1959."

(3) Traffic Control Light - Patterson - Kingsway intersection.
