JUNE 13, 1960

A Regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway on Monday, June 13, 1960 at 7:30 p.m.

PRESENT:

Reeve A. H. Emmott in the Chair; Councillors Brown, Drummond, Edwards, Harper, Jamieson, MacSorley, Mather and Prittie

Reverend W. Little led in Opening Prayer.

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR JAMIESON:

"That the minutes of the meetings held May 24th, May 30th and June 6th, 1960, respectively, be adopted as written and confirmed."

CARRIED UNANIMOUSLY

Secretary, Burnaby Junior Chamber of Commerce, submitted a Tetter inviting the members of Council to attend the Western Canada Effective Speaking Contest on June 15th at the Gai Paree.

> MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR MATHER:

"That the letter be received and the invitation accepted."

CARRIED UNANIMOUSLY

Secretary, Committee on Planning, Lozells Community Association, submitted a Brief expressing concern as to the action taken by Council with respect to industrial development in the Government Road - South Burquitlam area and requesting that no further or final steps be taken toward the adoption of either a Community Plan or an Official Community Plan for this area until the Association has had the opportunity of preparing and presenting its case in support of additional but controlled industrialization for the area in question.

MOVED BY COUNCILLOR JAMIESON, SECONDED BY COUNCILLOR HARPER:

"That the Grief be received."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR DRUMMOND, SECONDED BY COUNCILLOR EDWARDS:

"That Council accede to the request of the Association to refrain from implementing an Official Community Plan for the Government Road - South Burquitlam District until such time as the Association has submitted its thesis on the matter of industrial development for this area and further, that the Association be informed that Council has adopted a Community Plan for the subject area."

CARRIED COUNCILLOR JAMIESON AGAINST Mr. J. A.W. Drysdale, M.P., Burnaby - Richmond, wrote embodying a letter which he had received from the Postmaster General explaining the situation with respect to postal designation for Burnaby and, in particular, the circumstances appertaining to the mailing address for Timber Preservers Limited.

MOVED BY COUNCILLOR HARPER, SECONDED BY COUNCILLOR PRITTIE:

CARRIED UNANIMOUSLY

Secretary, Brentwood Park Ratepayers Association, submitted a letter from residents of the South side of the 4700 and 4800 Blocks Ridgelawn Drive in which a request was made that their lane be paved at the earliest possible date. The residents indicated in their letter that they were prepared to pay the cost of this paving up to the point where the lane narrows to ten feet. The residents also advised that they were aware of Council's refusal to allot a sum for the acquisition of the land required to widen the narrow portion of the lane in question.

The Municipal Clerk advised that a request had been made of the Engineering Department for its views as to the suggestion of the residents that the lane be paved up to the point where it narrows to ten feet.

The Committee advised that it felt the \$700.00 grant made to the Boy Scout movement earlier this year was quite substantial and that therefore no further funds should be provided. They recommended that the application be denied.

REPORT OF TRAFFIC SAFETY COMMITTEE

(1) Request for Crosswalk in middle of 4400 Block Hastings St.

The Committee reported it had received a petition from a number of owners and occupiers of premises in the 4400 Block Hastings Street requesting the establishment of a crosswalk in the middle of the Block. The Committee advised that to accede to this request would likely precipitate similar applications for the

establishment of mid-block crosswalks in the other blocks in the Hastings Street business district and that it would prove difficult to resist these applications. The Committee also pointed out that the signol installation at Willingdon Avenue, together with the "Stop When Occupied" crossing at Rosser Avenue, provide adequate means of safely crossing Hastings Street in the affected block. They added that because Hastings Street is a multi-laned Highway, establishment of a mid-block crossing would create more of a hazard for pedestrians and would only serve to seriously impair the efficiency of vehicular movement. The Committee recommended that the application for the crosswalk be denied.

MOVED BY COUNCILLOR HARPER, SECONDED BY COUNCILLOR MATHER:

"That the recommendation of the Committee be adopted."

CARRIED UNANIMOUSLY

(2) Bus Stop at Rumble Street and Sussex Avenue.

The Committee reported it had received a request from the B.C. Electric Railway Company Limited for the relocation of the present eastbound bus stop on Rumble Street nearside Sussex Avenue to a northbound position on Sussex Avenue farside Rumble Street. The Committee recommended that approval be granted to the relocation of the bus stop in question.

MOVED BY COUNCILLOR MATHER, SECONDED BY COUNCILLOR JAM!ESON:

"That the recommendation of the Committee be adopted."

CARRIED UNANIMOUSLY

(3) 19th - 20th Street Diversion at both Stride Avenue and 10th Avenue.

The Committee reported that with the opening of the new Queensborough Bridge considerable change is expected in the character of traffic movements in the above noted area. They recommended that the 19th - 20th Street Diversion be designated as a through street between Stride Avenue and 10th Avenue. They also recommended that since the stop sign for eastbound traffic on 10th Avenue will be inside the boundary of D.L. 172, both the Provincial Government and the City of New Westminster be informed of the proposed treatment for the Diversion. The Committee added that advance warning Railroad crossing signs would be erected at the approaches to the Spur track crossing the Diversion south of 14th Avenue.

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR EDWARDS:

"That the recommendations of the Committee be adopted."

CARRIED UNANIMOUSLY

(4) <u>Curb Space and Bus Stop in front of Abbotsford Bakery on Kingsway east of Griffiths Avenue.</u>

The Committee reported that it had received a request from the above Company to abolish the parking restriction in front of its premises and relocate the bus stop sign four feet further west of its present position. They reported that investigation

disclosed the space available is no more than adequate for the use of the bus and would be required at such time as the stop is replaced with a zone and further, that the area at the curb where the restriction exists is required to accommodate the pull-out movement of the bus. The Committee recommended that both requests be not entertained.

MOVED BY COUNCILLOR PRITTIE,
SECONDED BY COUNCILLOR MacSORLEY:

"That the recommendation of the Committee be adopted."

CARRIED UNANIMOUSLY

(5) Regulation and Control of Billboards Adjacent the Freeway.

The Committee reported that it wished to record its support of a proposal to introduce legislation to regulate and control the erection of billboards and other similar advertising devices adjacent the Freeway.

MOVED BY COUNCILLOR JAM!ESON, SECONDED BY COUNCILLOR MATHER:

"That the report of the Committee be received."

CARRIED UNANIMOUSLY

(6) Glenwood School.

The Committee reported that an anomaly exists on Marine Drive adjacent the above school in that a 15 m.p.h. zone exists together with a "Stop When Occupied" crosswalk. The Committee recommended that the 15 m.p.h. signs be not replaced at the commencement of the school fall term and, instead, the pavement of Marine Drive be painted to indicate the approach of a crosswalk. They also recommended that the School Board be requested to provide a patrol at the subject crosswalk.

MOVED BY COUNCILLOR JAMIESON, SECONDED BY COUNCILLOR MacSORLEY:

"That this matter be referred back to the Committee for reconsideration."

CARRIED UNANIMOUSLY

(7) South side of Edmonds Street east of Britton Street.

The Committee reported that some congestion of traffic is anticipated in the vicinity of the above intersection consequent upon the opening of Dominion Stores. They recommended:

(a) That stopping be prohibited on the south side of Edmonds Street from the east property line of Britton Street to

the east property line of Linden Avenue produced.

(b) That the existing bus zone on the south side of Edmonds Street east of Britton Street be relocated to the south side of Edmonds Street from 42 feet east of the east street line of Linden Avenue produced to a point 107 feet further east.

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR JAMIESON:

"That the recommendations of the Committee be adopted."

CARRIED UNANIMOUSLY

Councillor Jamieson submitted a report in connection with the use of capital equipment by the Parks and Recreation Commission and the Engineering Department advising that the present system of interchange of this equipment ensures a higher usage factor by the Parks Department. He advised that it was felt, however, that when further expansion of the capital equipment of the Parks Department is considered, some economies may be realized by combining the Park purchase with other equipment. He suggested that the Council should perhaps investigate the establishment of an equipment pool, which would administer, dispatch and maintain all equipment, and report directly to the Manager in order to avoid any inter-departmental conflict. Councillor Jamieson added that the Commission has not overcapitalized and that there does not appear to be any duplication of mechanical services.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR HARPER:

"That the report be received,"

CARRIED UNANIMOUSLY

- (1) The Manager submitted the report of the R.C.M.P. covering policing activities for the month of May, 1960.

CARRIED UNANIMOUSLY

(10) Boat Launching Station on North Arm of Fraser River.

The Manager subm^ftted a communication from the Parks and Recreation Commission in which they set out their views with respect to the matter mentioned in caption above and also the establishment of a marina on Burrard inlet. The Manager pointe out that the recommendations of the Commission passably

concur with the view that there is no known need for a boat launching ramp on the North Arm of the Fraser River and, in fact, the Commission was recommending that the Wiggins Street site be utilized to test the demand for such facilities. He also pointed out that the Commission was recommending that every effort be made to provide suitable public access to Burrard Inlet though no positive recommendation was made concerning a marina on Burrard Inlet. The Manager advised that he felt the onus of proof for such need is properly that of the Parks and Recreation Commission and recommended that the Commission be requested to explore a method of testing such a need and to submit an estimate of the cost, together with details of the proposal including arrangements which are deemed requisite for the use of the property so that Council can properly assess the need for the facility in question and, if justifiable, provide the necessary funds. The Manager also advised that he concurred with the recommendation of the Commission regarding suitable public access to Burrard Inlet.

The Manager reported verbally that the Provincial Government is currently investigating the alignment of Barnet Highway with a view to determining the feasibility and practicability of relocating portions of it so as to avoid the incidence of disturbance to the road.

MOVED BY COUNCILLOR JAMIESON, SECONDED BY COUNCILLOR HARPER:

"That the recommendation of the Manager respecting the matter of a boat launching station on the North Arm of the Fraser River be adopted."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR PRITTIE:

"That the matter of a marina on Burrard Inlet be tabled pending receipt of further information concerning the plans of the Department of Highways with respect to Barnet Highway."

CARRIED UNANIMOUSLY

(11) Local Improvement Initiative Sidewalk Construction Programme.

The Manager submitted a report of the Municipal Clerk setting out the objections received against certain of the projects contained in the above programme. He pointed out that Items 7, 10, 11, 15, 16, 18, 20 and 21 cannot be undertaken as the petitions received were sufficient to estop Council from proceeding with these works. He recommended that the report of the Clerk be received and authority granted to proceed with the balance of the programme.

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR JAMIESON:

"That the recommendation of the Manager be adopted."

(12) Revised Cost Reports for the above Local Improvement Initiative Sidewalk Construction Programme.

The Manager submitted the report of the Engineer, as required under Section 600 of the Municipal Act, covering that portion of the above programme which was approved by the property owners. He recommended that this report be approved.

MOVED BY COUNCILLOR MATHER,
SECONDED BY COUNCILLOR PRITTIE:

"That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

(13) North American Peat Limited Leases on Lands in D.L.'s 1550, 1550 and 166A.

The Manager reported that portions of the above District Lots have been held in lease by the above Company for approximately twenty years and that the leases contain an option clause under which the Company can purchase the property for the sum of \$50.00 per acre. He advised that the Company has notified the Corporation that it wishes to exercize the option and, in this respect, has forwarded a cheque in the amount of \$7,147.00. He added that on March 28, 1945, an Act known as "Burnaby Peat Leases Validation Act" was obtained by the Municipality covering the leases in question. The Manager recommended that the Municipal Solicitor be instructed to examine the leases and advise Council of its legal position with respect to the option clause in the subject lease.

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR EDWARDS:

"That the recommendation of the Manager be adopted and, in addition, the Solicitor also examine the Act referred to above to determine the extent of our obligation and further, that he advise of the situation in regard to past attempts of the Municipality to annul the lease agreement."

(14) Burnaby Building By-Law 1926, Amendment By-Law 1960.

The Manager reported that the above Amendment covers the matter of relative accommodation which Council had approved some time ago. He pointed out that the regulations are less stringent than for suites but that they have been devised to ensure a good standard of accommodation. He recommended that Council approve the Amendment by-law.

MOVED BY COUNCILLOR HARPER, SECONDED BY COUNCILLOR MATHER:

"That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

(15) Burnaby Subdivision Control By-law 1955, Amendment By-law, 1960.

The Manager reported that the purpose of this Amendment was to add Section 708(1)(c) of the Municipal Act to the Subdivision

Control By-law. He advised that this Section reads as follows:

"The Council may regulate the subdivision of land, and for that purpose may be by-law:

Require that a proposed subdivision:

- (a) Be suited to the configuration of the land being subdivided; and
- (b) Be suited to the use to which it is intended; and
 (c) Shall not make impractical the future subdivision of the land within the proposed subdivision or of any adjacent land."

The Manager recommended that this Amendment be approved.

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR DRUMMOND:

"That this matter be tabled for a period of one week."

CARRIED

(16) Tractor Loader.

The Manager submitted a tabulation of tenders received for the sale of a tractor-loader to the Municipality recommending that the tender of Finning Tractor and Equipment Company for the supply of one Caterpillar Traxcavator #933 at a net price of \$11,254.00, not including S.S. Tax, be accepted.

The Reeve declared a recess at 9:20 p.m.

The Manager submitted a report of the Municipal Solicitor in which the powers of the Zoning Board of Appeal were set out and explained. The Manager pointed out that the Solicitor is of the opinion that the Board had full authority to deal with the erection of a radio antenna on property at 240 North Glynde Avenue.

(18) Business Tax.

(19) The Manager submitted a report of the Municipal Clerk on his attendance at the 21st Annual Conference of the Municipal Officers' Association of B. C. which was held in Victoria between May 30th and June 1st, 1960.

(20) Braemar Street Allowance.

The Manager recommended:

- (a) That Council approve the abandonment of a portion of Braemar Avenue between the south boundary of Hazard Street, as widened to the ful! 66-foot allowance, a distance of 250 feet more or less; all as shown on Planning Department Drawing A-1077.
- (b) That the Solicitor be instructed to prepare the necessary By-law to effect this abandonment.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR EDWARDS:

(21) Lot 23, Block 10, D.L. 12!, Plan 1054.

The Manager advised that it is felt this use would be incompatible with surrounding development and that the creation of a parking lot would generate traffic onto Pender Street, all of which is considered to be undesirable. He recommended that the application of Burnaby Funeral Directors for the use of the property in question as a parking lot be denied.

(22) Burnaby Special Sewer Account By-law 1960.

The Manager reported that this By-law enables the sewer utility to make use of the unexpended balances totalling \$174,494.62 under construction by-laws 2026, 3145, 3146, 3266, 3471, 3472, 3588, 3820, and 3821. He pointed out that normally these unexpended amounts would be used to reduce the related tax levies but that with the approval of the Sewer Financing By-law, it is no longer necessary to apply these surplus monies strictly to local areas. He recommended that the By-law in question be passed by Council to permit these surplus funds to be used for sewer construction; the funds to then be applied as market conditions make it feasible to dispose of the securities concerned.
