

APRIL 4, 1960

A Regular Meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, April 4, 1960 at 7:30 p.m.

PRESENT: Reeve Emmott in the Chair;  
Councillors Brown, Drummond,

Reverend E.G. Byers led in Opening Prayer.

MOVED BY COUNCILLOR EDWARDS,  
SECONDED BY COUNCILLOR JAMIESON:

"That Minutes of the 14th and 21st of  
March be adopted as written and confirmed."

CARRIED UNANIMOUSLY

The Burnaby Board of Trade wrote requesting an opportunity to speak to the Council in connection with a grant to assist the Board's current industrial programme. Mr. Hughes attended and presented a brochure entitled: "Industrial Burnaby on Parade" publicizing an Industrial exhibition to be held at the Central Burnaby High School during the month of May. Mr. Hughes requested that favourable consideration be given to their application for a grant to assist in this programme and also to provide for suitable gift presentation to be made at the forthcoming Junior Chamber of Commerce in Calgary, similar to that made at other conventions in Eastern Canada.

His Worship the Reeve advised the Grants Committee had discussed this application informally and it was felt the Committee would be in a position to recommend favourably.

Mr. A. Brown-John requested an opportunity to appear before the Council in connection with the truck hiring policy. Mr. Brown-John appeared and presented certain figures portraying payments made to truckers for trucking work carried out for the Corporation of Burnaby during the years 1958 and 1959. The figures indicated Mr. Brown-John received less truck hauling work from the Corporation than the others listed. Mr. Brown-John condemned the truck hiring policy and appealed to the Council for fair play, pointing out that he was a long time resident of the Municipality and a citizen of some standing. Mr. Brown-John pointed out the Stride List no longer existed and demanded that Burnaby use his trucks in the future. The Executive Assistant outlined the procedures followed in the truck hiring operation at the time the Stride Pit was in operation, pointing out that the Stride List had been established through the efforts of a joint committee of truckers and Corporation officials. Since discontinuation of the Stride Pit and consequently the Stride List, specifications were being drawn for the purpose of placing the gravel hauling requirements out to public tender.

Mr. Brown-John made certain allegations directed at His Worship the Reeve which were denied by the Reeve and the meeting was adjourned.

The meeting reconvened within a few minutes time.

(8) The Manager submitted an Amendment to the "Burnaby Fire Prevention By-law 1936" prepared by the Municipal Solicitor which effected a change in the establishment of procedures for permitting outdoor fires, repealing sections dealing with the setting up of certain fire limits and substituting a system of permits to be issued by the Fire Chief for the setting of outdoor fires at any time.

The By-law also repealed Section 3 dealing with the right-of-way of Fire Department apparatus and Section 10 which empowers the Fire Prevention Officer to order buildings to be torn down when considered necessary to prevent the spread of fire. The Solicitor submitted that both these sections were ultra vires, the former due to the fact that this matter was now dealt with in the Motor Vehicle Act.

(9) The Manager submitted a report on Municipally owned land at 6564 Royal Oak Avenue presently leased to the Salvation Army for \$240.00 per year. The Salvation Army expressed a desire to purchase the site and the Property Manager placed a value of between \$6,000.00 and \$6,500.00 and a compromise value at 16 x \$240.00 plus the 1959 assessed value or \$5,435.00 (the 16 determined from the remaining 16 year life of the lease). The offer of the Army of \$1,750.00 had been made some time previously and it had been suggested the existing lease appeared to offer the best terms and protection. However, the Army had renewed its request and agreed to give up ten feet required for lane purposes. Having regard to the present and proposed use of the property and the terms of the Municipal Act coupled with the tendering policy of the Council it was recommended the property be placed in a sale position.

(10) The Municipal Manager submitted a comprehensive report on the variation of construction costs as opposed to estimated costs of Local Improvement works for 1959 specifically involving By-laws Nos. 3947, 4016 and 4062 (pavement) pointing out that the constructed costs had proved considerably greater than the estimated costs and requesting the authority of the Council to pass a By-law pursuant to Section 596(a) of the Municipal Act accepting a percentage of the costs as calculated for each By-law as a charge upon the General Revenue of the Corporation.

Similar material was given in regard to sidewalk works as authorized by Construction By-Laws Nos. 4035 and 4061.

The Manager gave full details of the reasons for the variation in costs and advised of steps being taken to correct future cost accounting procedures.

The Manager submitted comparisons of lease arrangements entered into in the Municipality of Richmond and the City of Vancouver which compared very favourably with the recommended lease fee in this instance of 7% of the assessed value of the land plus the current taxes on land and improvements in accordance with Section 334 of the Municipal Act.

The Council then proceeded to deal with the property rezonings contained in Town Planning By-Law Amendment Nos. 1 and 2, 1960 as detailed in Page 2 of the report of the Planner dated March 31, 1960 entitled: "Rezoning Applications". The Director of Planning commented on Items 1 to 3 as follows:

Item 1 -- Lot 1E $\frac{1}{2}$  except West 75 feet, Block 14, D.L. 70 East 50 ac. of West  $\frac{1}{2}$ , Plan 3024 save and except the south 20 feet thereof.

The Planner advised the architect for the applicant had submitted that the conditions laid down in the report of the Planner, No. 94/59, had been complied with.

Item 2 -- Lots 2C, 3D, 3E, Sketch 12375, Blocks 2/4, D.L. 28N, Plan 2162 save and except the North 7 feet and the South 31 feet and Lot 3F, Blocks 2/4, D.L. 28N, Plan 2164 save and except the North 7 feet and the South 125 feet.

The Planner reported that written consent to the conditions contained in his report, Reference No. 84/59 had been complied with.

Item 3 -- Block 4 except part shown on By-laws 30078, D.L. 97, Plan 824 save and except the North 20 feet thereof.

The Director of Planning commented on the remarks of Mr. Carlyle, owner of Lots 5 and 6, Block 12, D.L. 93 and the contention that arrangements had been made for subdivision of the property and rezoning of the South 200 plus or minus feet for commercial purposes. The Director of Planning submitted that he had no record or recollection of a discussion regarding the commercial zoning of the South part of this property (Planning Reference 89/59).

Item 4 -- Lot "H", Block 12, D.L. 151/153, Plan 10218.

It was submitted by the Planner that the applicant had requested withdrawal in view of the heavy estimated cost of providing services as stipulated in the rezoning recommendation. (Planning Reference 98/59)

Item 5 -- Lots 1 and 2, Block 39, D.L. 151/153, Plan 2884.

The Planner recommended that these two lots be consolidated since the area of the two existing lots was not sufficient to enable rezoning for Multiple Family Type I purposes. It was pointed out this was not a spot zoning but was an extension of an existing zone and could be considered further on evidence of consolidation.

Items 6 and 7 -- Lots 6 to 12 inclusive, Block 8, D.L. 151/153, Plan 2155 and Lots 2 to 9 inclusive, Block 9, D.L. 151/153 Plan 2072.

The Planner submitted a development plan of a plant development involving land to the south legally described, Lots 5 and 10 of Blocks 8 and 9, D.L. 151/3 and discussion ensued on the merits or demerits of rezoning the land to the north for Multiple Family purposes in view of this development particularly in relation to the establishment of an industrial plant on Lots 5 and 10 aforesaid; one of which was located north of a lane allowance which was considered to be a good buffer between the industrial and residential areas. The general feeling was that the proposed rezonings for Multiple Family purposes in Blocks 8 and 9 should be withheld.

Item 8 -- Lot 5, Block 10, D.L. 151/3, Plan 1214.

It was submitted by the Planner that the applicant desired to withdraw his application. The Planner suggested that the recommendation of his Department still stood but the possibility of acquiring the lane stipulated in the Planner's report (Planning Reference No. 1/60) was somewhat remote in view of the withdrawal action of the owner.
