MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR BLAIR:

CARRIED UNANIMOUSLY

Community Planning Association of Canada, Fraser Valley Branch, submitted an invitation to the Members of the Council to attend a meeting at the Matsqui Room, Park Hotel, Abbotsford at which time the report of the Lowe. Mainland Regional Planning Board relating to Industrial Land Prospects in the Lower Mainland of British Columbia would be discussed. The invitation was received and those Members of the Council who were able were asked to attend.

Willingdon Heights Community Centre Association wrote requesting permission to hold their Annual Community Day Parade on Saturday, June 9th in the North Burnaby area.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR CLARK:

"That permission be granted subject to the approval of the R.C.M.P. and the Municipal Engineer in accordance with the Street and Traffic By-Law."

St. John Ambulance Association of New Westminster extended an invitation to the Council to attend the Annual Review of its brigades and divisions from Burnaby, New Westminster and Surrey and the District of Coquitlem to be held in the Arenex, Queens Park, on the 20th of February.

The invitation was received and noted by the Members of the Council.

Community Planning Association of Canada, B. C. Division, wrote advising of an orientation course in Community Planning to be held at the University of British Columbia from May 14th to 19th to cover a wide variety of subjects and case studies involving Municipal planning problems. The fee for the course was \$35.00.

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR CLARK:

"That the invitation be received and that the registration fee be paid out of Municipal funds for any Members of the Council planning to attend this course."

L. A. Christensen and others wrote protesting a proposal to move an old house onto property situated between 6535 and 6541 East Georgia Street on the grounds that the location of this home on this property would depreciate surrounding properties.

The Manager presented a report of the Chief Building Inspector which detailed the circumstances and which advised that the application for moving permit was first made on January 19th, 1962 and that the Department had considered carefully the architectural compatibility of this home on the proposed new site.

The home was constructed in 1946 and a feature of the building characteristic of the date it was built, was found in the presence of flush eaves at the gables and the pitch of the roof was slightly greater than that of some of the bungalow type homes currently built. Other than this, it would be difficult to determine the age of this home if it were redecorated on the outside.

The Department further submitted that the Assessment Department had been asked to give an opinion of the effect on values this home would have when placed on the site and it was the Assessment Department's opinion that no detrimental effect on values would result. Arrangements had been made for the home to be placed as low as possible and to maintain the general low line of the bungalow style homes on the street. Plans indicated that all trim and stucco would be refinished or repainted, that the main floor elevation would be kept in line or below the main floor elevation of existing neighbouring homes and the basement windows all around would be replaced with aluminum sash. It was further submitted by the Department that the alarm presented by the residents in the neighbourhood was understandable in that the removal of any home takes on an untidy appearance until the reconstruction is well advanced and that in most cases the finished product was quite acceptable. It was further pointed out that if the Department had received an application for Building Permit to build this home as a new structure there would have been no reason to refuse it.

The Manager presented pertinent details of the Building By-Law concerning the removal of buildings in the Municipality for the information of the Council.

(a) Proposed 1962 Budget of Lower Mainland Regional Planning
Board. This item tabled from the meeting of February 12th
was lifted from the table.

Councillor Prittie, Chairman of the Lower Mainland Regional Planning Board gave a brief resume of the activities of the Board during 1961 and plans for the year 1962. Councillor Prittie drew attention to the fact that there were two portions to the request of the Board for budgetary considerations;

- that specific approval be given to the inclusion of the Board's staff under the Provincial Superannuation scheme and,
- (2) that the 1962 Budget, as outlined, be adopted necessitating an assessment upon this Corporation of \$4,453.00.

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR HARPER:

"That this Corporation approve the proposal of the Lower Mainland Regional Planning Board to include its staff under the Municipal Superannuation scheme."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR BLAIR:

(b) Letter from Shell Oil Company of Canada Limited re complaint of the Westridge Ratepayers' Association. This item was tabled from the meeting of February 12th and was lifted from the table.

A letter was read from the Shell Oil Company, accompanied by a copy of a reply to the Westridge Ratepayers' Association in response to a complaint by the Association of odours and smoke nuisance emanating from the Plant recently. The Company advised that a recent emergency condition necessitated some flaring of gas and smoke and that apart from this the record of the Company had been extremely good in this respect. The odour problem was one that was under continuous study by the Company in the interests of safeguarding against similar occurrences.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR HARPER:

"That the correspondence be received and the Company be commended for the action taken to date on the elimination of odour and smoke nuisances from the Plant and further that the Council trusts that further efforts in this regard will lead to complete success."

(c) Membership fee in the Greater Vancouver Metropolitan Industrial Development Commission. This item was tabled from the Council meeting of February 12th when His Worship the Reeve submitted a recommendation that the membership fee in the Commission for the year 1962 be paid in the sum of \$4,886.50, representing the regular basis of 5¢ per capita.

REPORT OF POLICY COMMITTEE.

Your Committee met on Tuesday, February 13th, 1962, jointly with the Board of School Trustees to consider the Budget presented for School District #41 (Burnaby) for the year 1962.

A full discussion was held on the three major components of the Budget:

- (1) Instruction Account including expenses of the teaching staff.
- (2) Other Operating Expenses including maintenance and supply.
- (3) Special Services Health, Dental, etc.

The Board submitted that during past years the per pupil cost of education in Burnaby was lower than the Provincial average. Increases in the Budget are due primarily to growth of the system and teacher service negotiations. Total staff is about

800, reflecting an increase of 51 in teaching staff this term.

The teaching staff is operated on a six category certification basis ranging from "Elementary Conditional" to "Professional Advanced". Certification within these categories coupled with length of service, in the main, governs the salaries paid. Burnaby's reputation for teacher services is high due to the adoption of this system.

Maintenance expenses are accepted as shareable by the Provincial Government up to 2% of the plant value (\$18,000,000) and the current Budget reflects close conformity to this percentage.

Your Committee is of the opinion the operation of the school system has been conducted in a careful manner and the current Budget indicates a continuation of this practice.

Your Committee would recommend the adoption of the 1962 estimates as presented by the Board of School Trustees, School District #41 (Burnaby) on February 1st, 1962, in the total sum of \$8,217,544.00.

REPORT OF PUBLIC UTILITIES COMMITTEE.

(1) Transit Service - Broadway Area

Your Committee has given consideration to a petition from 219 residents in the Parkcrest area requesting bus service in the area of the Lougheed Highway and Holdom Avenue and points east and north.

We also received a letter from the B. C. Electric Company Limited in which approval was sought for a diversion of the "Kitchener" bus route to meet the request of the petitioners.

The Company advised that its proposal is to divert the Kitchener bus which operates westbound on Halifax Street to route via Halifax Street, Fell Avenue, Broadway, and thence north on Holdom Avenue. The Company pointed out that this diversion would be from 6 a.m. to approximately 6 p.m. daily, except Sundays; the reason for this type of service being that there is insufficient operating time after 6 p.m. and on Sundays to permit the diversion at these times.

The Company further mentioned that this re-routing would mean that regular passengers on the "Kitchener" bus would be carried an additional .40 miles and that each trip would require approximately two minutes additional running time. They pointed out that the diversion can only be made permanent if an average of three passengers board or alight each bus at the stop on Fell Avenue at Broadway; if this volume is not attained, then it is planned to revert to the present regular routing.

Your Committee feels the proposal of the Company is acceptable so we would therefore recommend that the request of the B. C. Electric Company Limited to divert the Kitchener bus service along the route above outlined on a trial basis, be approved.

(1) 1962 Conference of Canadian Building Officials.

The Municipal Manager recommended that Mr. M. J. Jones, Chief Building Inspector, be authorized to attend the Conference of Canadian Building Officials to be held in Calgary, Alberta, from April 25th to April 27th.

Tenders were opened on February 5th. The Engineer's specification called for prices on approximately 20,000 tons of asphalt. Since the plants operated by bidders are in different locations, the bidders were required to establish Haul Rates and Zones within their bids.
